

## YMCA of Marquette County Membership Rates – Military Effective February 15, 2016

Military is defined as an adult who is active duty military or a disabled veteran. A Military ID and/or a letter stating disabled status is required at joining.

\* A Family is defined as one or two financially dependent adults residing in the same household and their dependent children, up to age 24. The subsidy is based on the age of the military member.

\*\* A Senior Couple is defined as two adults residing in the same household, both ages 65 or older.

**Other** Memberships: Financial Assistance is available for youth, adults and families in need through the YMCA Financial Assistance Program.

**Monthly Payments:** YMCA memberships run from the join date to the 15th of the month. The first month's prorated membership dues, plus applicable joining fees, and printed documentation of bank account and routing number or debit/credit card are due at the time of enrollment. Monthly payments will be drafted on the 15<sup>th</sup> of each month. All returned payments (checks, electronic funds transfers and credit card payments) will result in a \$20 fee after the second attempt to process payment. All outstanding balances and fees must be resolved before the member can participate in any YMCA programs. The YMCA is in no way responsible for any additional fees charged by your financial institution.

**Hold Policy**: Memberships may be placed on hold when requested in writing by the 25th of the month. Drafts will automatically resume on the hold end date, without notification. Full pay memberships will be extended as needed. Financial Assistance memberships are not eligible for placing hold.

**Monthly Cancellation/Change Policy**: YMCA memberships are continuous and automatically renewing and will remain in effect until a written cancellation form is received. Cancellations and other membership changes must be received by the 25th of the month. We reserve the right to cancel memberships due to non-payment or denied drafts.
