Thank you for your respect with regards to copyright law. We appreciate your policy requiring competition participants to receive written permission for using copyrighted songs. We realize that because of your policy students are learning how to properly obtain permission to use intellectual properties.

However, we spent a great deal of time last winter and spring issuing permissions to these students at no cost to them. The issuance of these permissions does cost us money in postage and for long distance phone calls and faxes. Because of this, we will not be faxing or mailing any permission letters on a gratis basis to students. If we must fax or mail their permissions, there will be a \$15.00 minimum processing fee. This charge can be avoided if students will utilize the resources mentioned in this letter. Please encourage students not to call, but to use our website if needed.

We would also appreciate your use of this letter as a blanket license covering all judges' copies needed for EMI Christian Music Publishing songs. You may keep this letter on file and students may copy or fax it as needed. This gratis license is granted to you with the provision that all judges' copies be destroyed after the student's final stage of competition.

The ownership of our songs may be researched via our website which is listed at the top of this letter. Please ask students to visit our website rather than to call. Also, you may refer students to CCLI's website for song information at www.ccli.com. They may research songs on the "Song Select Online" and "Administered Publisher List" pages. Please let me know if you have any questions regarding this permission and best wishes to every student involved in competition.


