Dr. Harold Simmons, National Commissioner of the National Baptist Criminal Justice Commission, stated, "The National Baptist Criminal Justice Commission is pleased to hold its 2<sup>nd</sup> Annual Criminal Justice Luncheon during the 136<sup>th</sup> Annual Session of the National Baptist Convention USA, Inc. We remain committed to helping those in need to restore and uplift the lives of men and women and their families. We invite ex-offenders, families, the law enforcement community, victims of crime and the general public that are experiencing challenges due to involvement with the Criminal Justice System to come to the Convention Center on September 6, 2016. Information regarding employment, legal services, mental health, and much more will be available. Organizers are expecting 12 ministries that work with people impacted by the Criminal Justice System to provide counseling and resource information beginning at *10am to noon. The Lunch begins at noon*.

Dr. Simmons stated, "Our research data indicates that after a decline in the correctional population, about 1 in 35 adults in the United States were under some form of correctional supervision at year end 2013 and 1 in 51 adults were on probation or parole at year end 2013".
