There is absolutely NO space for Health Fair exhibitors outside the official exhibit area. No roving entertainment or advertisement will be allowed. Posting and/or distribution *of* literature samples or souvenirs is permitted from the contracted space only! No Food or Drinks can be sold in the exhibit hall.
