# To Churches, Constituent Entities

regarding Letter of Eligibility to Vote in NBC, USA, Inc.

#### PRESIDENTIAL ELECTION - SEPTEMBER 4, 2014

By now, all Churches, Constituent Entities that are registered, and in financial standing with the National Baptist Convention, USA, Inc., have received a **Letter of Eligibility to Vote in the September 2014 Presidential Election**. The Eligibility Letter indicates the number of votes accorded each Church, Constituent Entity to cast in the NBC, USA, Inc. **Presidential Election on Thursday, September 4, 2014.**

Verification of Payment to NBC, USA, Inc.

(Accepted forms of documentation: Cancelled Check - front and back views, or Online Bank Receipt)

Verification of Registration with NBC, USA, Inc.

(Official Registration Receipt issued by NBC, USA, Inc.)

### **!!! NEW INFORMATION !!!**

#### At the upcoming Convention in September, Churches, Constituent Entities are urged to:

- ➤ At Registration Site: Pick-up Registration packets, and 2014 Official Voting Delegates Designation Form. The Official Voting Delegates Designation form (adhesive strip) must be completed (names printed and signed) by each individual voting delegate. NO EXCEPTIONS!
- ➤ Proceed to Election Supervisory Commission Credential Distribution Site: Present Registration Receipt (Pink Copy) and Official Voting Delegates Designation strip form to retrieve voting credentials.

Voting Credentials will be available for pick-up beginning Monday, September  $1^{\rm st}$  to Wednesday, September  $3^{\rm rd}$  from 7:00 AM to 7:00 PM.

CREDENTIALS WILL NOT BE DISTRIBUTED ON THE DAY OF VOTE
