1. A separate registration form must be completed for each courtesy driver vehicle registered.

2. NON-REFUNDABLE vehicle fees can be paid with CASH, MONEY ORDER or CERTIFIED CHECK. PAYABLE to MICHIGAN BAPTIST FELLOWSHIP (MBF) Mail to Dr. Solomon Smith Sr. address above. (Cut off date May 2, 2015)

3. Gas, Repairs, Accidents, etc., are the Responsibility of THE LICENSED INSURED DRIVER.

- 4. ALL DRIVERS MUST WEAR an Identification Badge, T- Shirt and MUST place an Official Courtesy Sign, (issued by the committee) in the right front window of the Vehicle.
- 5. The Transportation Committee MUST is able to contact drivers by cell phone at any time you are driving for the NATIONAL BPT CONGRESS for MBF.
- 6. The deadline for the registration is Saturday May 2, 2015. Any registration after this date, there will be a \$20.00 late fee.
- 7. **On June 13,2015** all kits (Identification Badge, Courtesy Vehicle Sign, and T-Shirt) will be picked up at the Greater Mt. Olive Church located at 661 W. Eight Mile Road, between Woodward and John R .Detroit Mi 48203 from 10: am to 7pm.
