# Mission to South Africa, Malawi and Swaziland

## **July 18: NEW YORK/JOHANNESBURG**

Depart New York JFK International airport via your South African Airways flight to South Africa.

**July 19: JOHANNESBURG** Upon your arrival in Johannesburg, South Africa you will be met and transferred to your hotel. Dinner and overnight in JOHANNESBURG.

**July 20: SOWETO.** Visit Soweto, a familiar name around the world, which is actually an acronym for Southwest Township. It is home for more than 2 million "blacks and coloureds" to use the designation of apartheid. The laws of apartheid had prohibited blacks from living within the city proper save for a few live-in female houseworkers. During the daylight hours, downtown Johannesburg looked just like Newark or Detroit. At night, it was suddenly all White as if someone had waved a wand and made the Blacks disappear. Their exodus was to the sprawling township southwest of Johannesburg, hence its name - Soweto. The name Soweto has been burned into our consciousness by the children's uprising against the hated *Bantu* education that prepared the Blacks for service jobs only and the Afrikan language for its usefulness to their prospective masters and employers. From the children's revolt until the present, Soweto was the scene, oft times the center, of the resistance against apartheid and the racist regime. Time and again, Soweto has been the site of confrontation between the proponents for liberation and the armed might of the South African Defense Forces. Nelson Mandela's home is in Soweto as well as Desmond Tutu's. The ground in Soweto is soaked with the blood of martyrs, men, women and children alike. As you approach Soweto on the super-highways, one can see a blue-gray smoke that hangs like a pall over the entire area stretching for 17 miles. Soweto in its expanse and nearly 50 communities would make ten Harlems! There is Orlando East, Orlando West, Kliptown, Chiewelo, Eldorado Park, Niceville, Lineas, Racecourse, etc. Time is allowed to meet and talk with residents. Visit the Holy Cross Anglican Church of Orlando West which was Bishop

Tutu's seat before he was elevated to Archbishop of South Africa. Afternoon, mission work. Return to Johannesburg.  
**Dinner and overnight in JOHANNESBURG**

**July 21:** Full day mission work in Johannesburg. Dinner and overnight.

**July 22: JOHANNESBURG/ BLANTYRE, MALAWI** After breakfast, transfer to the airport for your flight from Johannesburg to Blantyre. Upon your arrival in Blantyre you will be met and transferred to your hotel. Afternoon visit of the Mission. Return to your hotel for dinner and overnight in Blantyre.

**July 23:** Full day mission work in Blantyre. Dinner and overnight.

**July 24:** Full day mission work in Blantyre. Dinner and overnight.

**July 25: BLANTYRE/ JOHANNESBURG** Transfer to the airport for your flight to Johannesburg. Upon your arrival, you will be met and transferred to Manzini, Swaziland. Dinner and overnight.

**July 26:** Full day mission work in Manzini. Dinner and overnight.

**July 27:** Full day mission work in Manzini. Dinner and overnight.

**July 28: MANZINI/JOHANNESBURG/NEW YORK** Drive back to Johannesburg in time for your return flight back home.

**July 29: NEW YORK** Arrive New York the next morning, local time.

# TOUR CONDITIONS

**AIR TRANSPORTATION:** Economy class jet connecting IATA and ATC carriers. Airfare is based on SUPER APEX 6-21 days plus domestic add-on fares where applicable. Airfares are based on July 2015 rates and are subject to change without prior notice.

**BAGGAGE:** Limited to one normal size suitcase, the weight of which should not exceed 50 pounds. Flight bags, cosmetic bags, briefcases, and camera cases remain in the personal care of tour members and are not included in the 50 pounds.

**HOTEL ACCOMMODATIONS:** First Class Hotels; two persons sharing a double bedroom with private bath. A limited number of single rooms are available at \$650.00 supplemental cost. Confirmation required before departure.

**MEALS – TWO MEALS PER DAY:** Breakfast and dinner daily.

**SIGHTSEEING AND MISSION WORK:** As detailed in the itinerary, using comfortable and convenient transportation. The mission in Malawi will provide transportation to the participants. English speaking local government licensed guide. All entrance fees are included when applicable to specified sites.

**TIPS:** Tips associated with portage at the hotels, meal gratuities, GUIDES and DRIVERS rendering services totaling \$75.00 are NOT included.

**TAXES:** Service charges as imposed by lodging facilities, taxes by local administrations and government authorities on lodging are included on all services rendered to the group. Airport taxes and international border taxes where applicable abroad totaling \$690.00 are included in the price of the tour and subject to change without prior notice; passengers will be billed for the difference if any at the time of travel.

**THE TOUR PRICE DOES NOT INCLUDE:** Expense of passports, visa fees, laundry, wines, liquors, mineral water, lunches and after supper coffee or tea or items not found on the menu, excessive baggage expenses, and all items of a personal nature, plus those not listed as being included in the tour price.

**BOOKING AND CONDITIONS:** Deposit and payment. A deposit of \$300.00 per person is required at the time of booking. Final payment must be made no later than 60 days prior to departure.

Payments received after the dead line date will be subject to \$50.00 administrative fee, CTO reserves the right to cancel any passenger NOT paid in full 60 days prior to departure. Reinstatement of a passenger is considered a last minute booking.

Last minute booking, after June 12, 2016 will have to pay the applicable airfare at the time of booking and \$150.00 to cover administrative cost.

**CANCELLATIONS:** Cancellations must be made in writing. Cancellations made up to 90 days prior to departure, refunds will be made less \$100.00 per person administrative fee. Cancellations made 89-36 days prior to departure will be subject to \$300.00 per person administrative fee. Cancellations received 35 days or less prior to departure have to pay a charge equivalent to 75% of the cost of the basic tour from the Gateway City.

**NO SHOW NO REFUND.** Cancellation charges with medical reasons certified by a hospital and accepted by the airlines and suppliers will only be made based on refunds from suppliers and less \$300.00 per person administrative fee. **CANCELLATION INSURANCE IS HIGHLY RECOMMENDED.** No refunds for services or sightseeing rendered and not used by tour members. In the event departure does not reach the minimum required number prior to departure, Consolidated Tours Org. Inc. **RESERVES THE RIGHT TO CANCEL,** withdraw or change the tour in whole or in part at any time in the event a change is deemed necessary by CTO, Inc.
