**CONCESSIONS COMMISSION GOVERNING RULES AND REGULATIONS**

The standard rates for Concessions booth space is \$750.00.

The balance on all booths shall be paid thirty (30) days before the event date by certified check or bank money order.

No one will be able to set up until balance is paid. **THERE WILL BE NO EXCEPTIONS TO THIS RULE!!!**

Booths come with one six (6) foot table, two (2) chairs, one (1) Id sign and one(1) wastebasket.

The Commission reserves the right to cancel any contract if there is a conflict with the principles of the National Baptist Convention.

The Concessions Commission, Directed by Deacon Kerry L. Nelson, shall admit Exhibitors on the basis of space available.

**There will be absolutely NO space for Exhibitors outside the official Exhibit Area.** No roving entertainment or advertisement will be allowed. Posting and/or distribution of literature, samples or souvenirs is permitted from the contracted space only. No food or drinks can be sold in the Exhibit Hall. No animals will be permitted in the Exhibit Hall.

Tapes of Convention programs and activities, past and present, are not to be sold without the written authorization of President, Dr. Julius R. Scruggs. These tapes must bear the Convention label. The use of The National Baptist Convention U.S.A., Inc., name or the Convention theme on items for sale is prohibited without the written authorization of President, Dr. Julius R. Scruggs.

Products or firms not exhibiting may not be displayed or advertise in any Exhibit Area or elsewhere in the Exhibit Hall.

No Exhibitors shall sublet or share the whole or part of the booth space allotted. The Exhibitor agrees for him/herself and his/her employees to use the contracted space for lawful purpose only and will conform to all laws, ordinances and regulations.

**WARNING TO ALL VENDORS WITH SOUND**

All vendors are subject to sound levels that will be set by the Commission. If your level exceeds that which the Commission sets, you will be asked to turn it down. You will be given a warning on the first request. The second request will be followed by a fine of \$50.00 payable on demand. The third request you will be asked to leave the Exhibit Hall. You will be escorted out and prohibited from Exhibiting at future Conventions of The National Baptist Convention, U.S.A., Inc. No Refunds.

The Convention, It's agents and employees are not liable for damages to or for theft/loss or destruction of the Exhibitor's property or injuries to the Exhibitor, his/her representatives, agents or employees. All claims for any such theft/loss, damage, destruction or injury are expressly waived by the Exhibitor. The Convention will also be exempt from or indemnified for any claims or injury to any of the Exhibitor's representatives, agents or employees. The Convention, it's agents and employees will not be liable for failure to hold the Exposition as scheduled. Payments for booths will be applied to the next event, except for reason of fire or any act of God or public enemy or strike or epidemic or any law or regulation or public authority or any cause beyond the control of the Convention which make it impossible or impractical to hold the Exposition.

Be advised that Exhibitors are liable for a sales tax and may be contacted by the State Department of Finance, Revenue, Sales and Use Tax. .Persons violating these rules and regulations will be asked to leave the premises without a refund or payment forwarded to the next event.
