Q: What are the tax benefits of giving to Nampa Christian Schools?

A: An education tax credit matches a couple's gift to the NCS up to \$2,000 with a 50% tax credit and additional 30% tax savings. For example, when your taxes are filed, a gift of \$2,000 will only have cost you \$344. Please see the gifting chart on the back side of this brochure for more details (consult your tax advisor for specific tax questions).

Q: What is the Annual Fund?

A: Each year Nampa Christian Schools asks its alumni, parents, grandparents, and friends for gifts to the Annual Fund. This is one of the most important ways in which we are able to support the school. These tax-deductible gifts enhance many aspects of the school.

Q: I already paid a lot in tuition - Why should I give more?

A: Tuition does not cover all of the annual cost of educating students. Like most independent schools, NCS must rely on the Annual Fund to help bridge the gap between tuition income and the actual cost of operating the school.

Staff Benefits

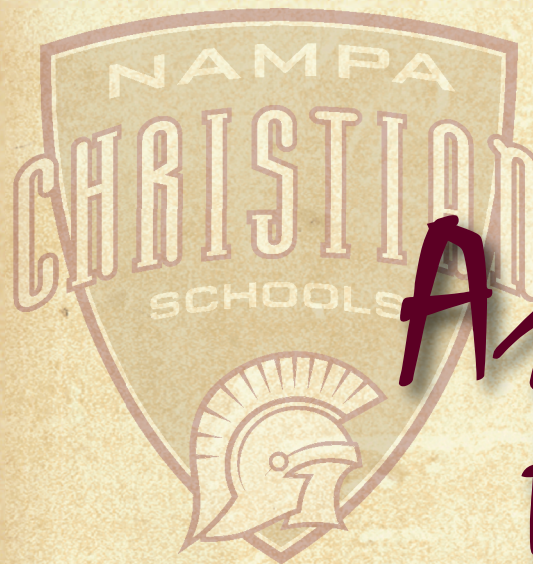
