

Additional Payment Policies

Fees- Enrollment fee is due at time of registration. Registration and Building Maintenance fees may be paid during July and August on a payment plan. Special payment arrangements may be made upon Board approval. Payments made to the account will be applied to fees first.

Participation Fees- Sports and class fees will be assessed and added to accounts after each sport or class has begun.

Enrollment- Students with past due accounts will not be allowed to register. *Exception:* A written plan to pay all past due accounts submitted and approved by the Board of Trustees.

Past Due Accounts (less than 30 days)- Parents will be contacted by the accounting office to help arrange a plan of correction.

Delinquent Accounts (more than 30 days)- A plan of correction must be submitted to the Board of Trustees for approval. Failure to present a plan or rejection of the plan by the Board of Trustees will cause the student(s) to be subject to dismissal. The final decision for permanently removing a student from school for non-payment rests with the Board of Trustees. Report cards will not be processed until such time as a decision is made by the Board.

Withdrawal Policy- Written notice to the school office is required if a student is withdrawn from school during the school year. If a student is withdrawn or expelled, tuition charges will be pro-rated based on the total number of days enrolled, using the actual date of expulsion or receipt of written notice or withdrawal for the calculation. Registration and enrollment fees will not be pro-rated and are non-refundable. Report cards and transcripts will not be processed until all accounts are paid in full.

After a student has withdrawn, for any reason, and after all efforts to collect past due or delinquent accounts have been exhausted, the school shall turn the account over to a collection agency.

Financial policies are subject to change, by the Board of Trustees, without notice.

Delinquent Charges

Per month interest of 1.5% (\$10 minimum) will be assessed on all portions of any accounts 30 days or more past due, including but not limited to tuition, fees, and interest. All monthly payments are due the first of the month and shall be considered past due after the 15th of the month. Statements of past-due balances will be mailed monthly.
