1. Gifts by Bequest

Gifts to Nampa Christian can be made with a simple statement in your will. "I give, devise, and bequeath (state the amount, asset, or percentage of estate) to (name and address of the School) to be used (describe use) or as the School's governing board deems appropriate." Depending upon size of your estate, your gift may significantly reduce final taxes.

2. Life Income Gifts

You can establish a trust or annuity that provides an attractive rate of guaranteed income during your lifetime, and a significant gift to Nampa Christian Schools. There are many configurations that can be tailored to your individual goals and circumstances.

3. Retained Life Estate Gifts
