CB01-R21 Understanding Law Enforcement Chaplaincy

This course will provide comprehensive and detailed instructions in understanding the purpose of law enforcement chaplaincy programs and items to consider when starting a chaplaincy program. This course will also identify differences between clergy & chaplains and specific items chaplains should do/should not do when serving their agencies.

CB02-R21 Law Enforcement Chaplaincy Basics

This course will provide comprehensive and detailed instruction in many basic elements of law enforcement chaplaincy. This course will include instruction and exercises in sensitivity and diversity, suggestions and recommendations in being relevant to, and connecting with, the agency and the officers whom the chaplain will serve and will provide detailed instruction in the participation of ride-alongs and law enforcement agency ceremonies and events, including law enforcement funerals.

CB03-R21 Legal Aspects of Chaplaincy

This course will provide comprehensive and detailed instruction in the legal aspects of chaplaincy. This course will include instruction in the disciplines of confidentiality, liability, officer and chaplain ethics as well as the legalities that surround sensitivity and diversity in regard to civil and political rights. Instruction will also be given regarding ICPC's Canon of Ethics.

CB04-R21 Law Enforcement Family

This course will provide comprehensive and detailed instruction in the many basic elements of what the law enforcement family is. This course will include instruction in the stages of the law enforcement career, identify unique stressors that affect the families of Law enforcement officers as well as stressors unique to the law enforcement career that bond officers into the thin blue line family.

CB05-R21 Responding to the Call-Out

This course will help chaplains identify a variety of crisis situations commonly encountered by law enforcement officials and potential responses to those crises. This course will provide comprehensive and detailed instruction in responding to call-outs and a chaplain's response before, during and after a crisis situation.

Completion of all 10 Chaplain Basic Courses provides 1.5 of the 3.5 CEUs required when applying for a Chaplain Basic Credential. Each course is offered only once at this event.

CB06-R21 Characteristics of Stress

Law enforcement officers have one of the most stressful jobs in the world. Our job as chaplains is to help them identify those stressors and manage them in a positive way that will help them be more productive in not only their careers but their family lives as well. This course is designed to give chaplain tools to help identify the types of stress Officers may be going through, signs of burnout, trauma and PTSD. You will also be able to help your officers become more resilient and understand that by managing the stressors in their lives they can have healthier careers and families.

CB07-R21 Suicide

This course will provide comprehensive and detailed information regarding suicide –reasons why people commit suicide, signs of suicide and other facts to consider to aid in the prevention of suicide. Officer suicide will be addressed as well as practical instruction for chaplains to assist officers within their department and when called upon to respond in the community.

CB08-R21 Department-Agency Incidents

This course will provide comprehensive and detailed instruction regarding chaplain responsibilities during department/agency incidents such as: responding to an officer involved shooting, line of duty deaths and officer injuries. This course also includes detailed instruction in planning and participating in law enforcement funerals and other ceremonies and events chaplains are called upon to assist with.

CB09-R21 Death Notification

Due to the frequent requests to have law enforcement chaplains either perform, or participate in, the delivery of a death notification, this course will provide comprehensive, step-by-step instruction and training in making such notifications. This course will define "notification," discuss common and predictable reactions to receiving a death notification and provide the ten steps of a successful death notification. Additional information and training are included regarding special circumstances and locations in which chaplains are required to perform death notifications.

CB10-R21 Self Care for the Chaplain

This course will provide comprehensive detailed instruction in the necessity of taking care of yourself as you serve as a chaplain. This course is designed to lay some fundamental and foundational principles and practices to assist the chaplain with sustainability and resiliency.

E01 - 21st Century Leadership: Passion Not Position

Becoming a leader is the greatest honor that can be bestowed upon an individual and, if taken seriously, it can be the apex of our lives – personally and professionally. While leadership can provide of a sense of accomplishment, too often leaders misunderstand what is being asked of them. Being a leader is a lifestyle that purposefully and positively influences the lives of those around them! The goal of this seminar is to be proactive in helping people become "leaders". Our focus is not on how to shape the vision of others; rather, it is on how we can assist others in being their best.

E02 - <u>Tourism Policing</u>

E03 - Building Strong Relationships with Your Officers

"What is the power of communication? Is it the words we use, the position we hold, or the information we give? Communication is more than these. It the desire, ability, and skill to connect with someone that moves the heart as well as informs the mind. There are 5 simple, yet profound principles of communication that open the door and 5 practices that keep the door open. Learning them by name will take a day. Living them purposely will take a lifetime. Communication with your officers and agencies with connecting." **Instructor: Chaplain Daniel Middlebrooks**

E04 - Microsoft 365/Teams

This course will cover basic sign-in to your ICPC Microsoft 365 account and accessing program applications such as Teams. Microsoft Teams is a persistent chat-based collaboration platform complete with document sharing, online meetings, videos and many more extremely useful features for organizational communications. E05 - Making Stress Your Friend, and Not Your Foe

In a world where stress is an everyday visitor, how do we change our perspective of this intruder from being a foe to fear to a friend we walk with. In this training, you will learn some valuable decisions that we all have to make when life (Stress) happens and how we continue moving forward on the journey of selfdiscovery and development. All of life is stress but we can make the choice to either make us better of bitter. Come learn some of these choices.

E06 - Walking With Them Through Shadows

The goal of this training is to consider what chaplains can do to assist officers, deputies, and agents as they deal with the traumatic events they encounter. This threefold approach includes:

•Ministry Of Presence – A ministry of presence is the foundational aspect of what we do as chaplains. In this training, we will define the concept of a ministry of presence and explain why it is so important in Emergency Services.

•Individual Support – In this training, we will take look at the impact critical events can have on emergency service personnel and outline a simple process that can be used to reduce its effect.

• Group Support - In this training, we will take a brief look at the benefits of group interventions and pro-

vide an overview of the group process – in particular, the Critical Incident Stress Defusing and Debriefings. (This is not a training class for CISM certification, rather a synopsis of the process and information about building a local Peer Support Team.)

E07 - <u>Bullet Proof Spirit</u>

For chaplains to effectively and compassionately serve, they need to not only be well but need to understand the nature of the daily traumas experienced by officers as well as themselves. Officer work traumas can not only injure our brain (causing PTSD) but can kill us (suicide is our #1 cause of death). Bulletproof Spirit describes how traumas affect our resiliency, motivation, health and wellness while providing 10 proactive, practical wellness strategies to enable any officer or chaplain to serve with purposed compassion in peace and wellness.

This training is based on the instructor's emotional survival and wellness guidebook, "Bulletproof Spirit: The First Responders Essential Resource for Protecting and Healing Mind and Heart," which is required reading at the FBI National Academy.

E08 – <u>Helping Those Who Are Grieving</u>

Grieving is one of life's most intense challenges and can be overwhelming for many. This class will give you a better understanding of grief and assist you in ministering to those deeply suffering due to great loss. **Instructor: Chaplain Mark Clements**

E09 - Worship Place Violence

Worship / School Place Violence Training – Implement various efforts to deter and reduce criminal risks and events that could lead to violence in places of worship, to include spiritual entities that also operate as schools of education. Provide effective training with understanding and comprehension of the following: What is worship place violence: Categories defined by OSHA: Media Relations; Stress Management. Instructor: Master Deputy Stanley Murray

E10 - PTSD and UCF Restores

In this presentation, Dr. Beidel will discuss trauma, its prevalence and its impact on first responders. The natural course of trauma symptoms, the individuals most likely to recover (or not recover), and the impact of trauma on the work, social, and physical functioning of first responders will be discussed. In this presentation, Dr. Beidel will also discuss the types of trauma that have led first responders to request treatment. Chief Neisler will then discuss how administrators must set an environment that allows first responders to seek the treatment that they need without fear of reprisal or demotion, etc. She will discuss what administrators need to know (and don't need to know) with respect to first responders in need and she will discuss the role of peer supporters, clergy and professionals. Dr. Beidel will conclude the presentation with a description of the innovative intensive treatment program at UCF RESTORES, which includes individual and group treatment. Dr. Beidel will also present the results of this treatment program for first responders - 76% no longer meet criteria for posttraumatic stress disorder after 3 weeks of treatment and the relapse rate, 6 months later, is 1%.

E11 - Watch Your Six: Because Making it Home is Just the Beginning

Officers often stress officer safety and "going home" at the end of the shift. In this inspiring and thoughtprovoking presentation, Jonathan asks, "What then?" to not only raise awareness about the real challenges facing law enforcement families, but also to offer advice for successfully navigating a thriving career and home life. The presentation concludes with participants completing a personal action plan containing goals that can be implemented immediately. This course will not only facilitate wellness in chaplains themselves, but also provide firsthand insight into the challenges facing the profession while equipping them with a framework for promoting wellness among those they serve.

E12 - What does an FBI Chaplain do?

How, when, and why the FBI chaplains program started. Why FBI leaders have said, "The FBI chaplains program is one of the most effective programs every created in the bureau. It ranks right up there with the highly successful 'Top Ten Most Wanted' program." The instructor will explain qualifications to be an FBI chaplain and how to get an application started. The course also covers the FBI Academy Resident chaplain opportunity, the FBI chaplain response to PENTTBOMB, and other deployments, as time permits. The instructor has been an FBI chaplain since 1993 and currently serves as the FBI Southern Region Chaplain Representative.

E13 - <u>Hindsight 20/20</u>

The course provides an overview of lessons learned responding to major peer support incidents, including the Pulse Night Club shooting, line of duty deaths, officer suicides, officer-involved shootings and infant fatalities. The course is designed to offer guidance for future response planning and to prepare peer support responders for what they might encounter when thrown into the midst of an emotional crisis. **Instructor: Chaplain Bernard Johns**

E14 - Adverse Childhood Experiences (ACE) 101

The goal of this 90 minute workshop is to provide attendees with a better understanding of the impact of significant factors on individuals in our community. These factors include Adverse Childhood Experiences (ACEs), chronic and toxic stress, and the benefits of Positive Childhood Experiences (PCEs). Also, to understand your role to help build a trauma-informed, resilient community while engaging individuals affected by these factors. The knowledge of the intergenerational transmission of adversity from parent to child validates the urgency to gain a rich understanding of the science behind toxic stress and engagement across sectors and to work toward prevention and equity in our communities.

E15 - Facing Legal Challenges to Chaplaincy Programs

This course will cover religious freedom issues affecting chaplaincies and ministries and include a Q&A. **Instructor: Attorney Roger Byron**

E16 - Human Trafficking

The objectives of this course are to understand human trafficking, be able to identify human trafficking victims, along with necessary steps in reporting and strategies for caring for this vulnerable population. Also covered will be what the Metropolitan Bureau of Investigation (MBI) is and its role in combating human trafficking from the (1) law enforcement, (2) prosecution, and (3) victim services perspective. **Instructor: Mr. Aaron Blankenship**

E17 – <u>Resiliency Screening</u>

RESILIENCE is a one-hour documentary that delves into the science of Adverse Childhood Experiences (ACEs) and the birth of a new movement to treat and prevent Toxic Stress. Now understood to be one of the leading causes of everything from heart disease and cancer to substance abuse and depression, extremely stressful experiences in childhood can alter brain development and have lifelong effects on health and behavior. Participants will participate in viewing the documentary followed by discussion. Film and discussion points include: (1) Defining Adverse Childhood Experiences and toxic stress, (2) Understanding the impact of ACEs and toxic stress, (3) Learning about the ACEs study and the outcomes, (4) Learning how ACEs can have an impact on our physical and mental health, (5) Identifying protective factor that can prevent ACEs, (6) Understanding the importance of building resilience.

E18 - Federal Chaplain Response to the Orlando Terror Attack

Two FBI chaplains responded to the Orlando terror attack investigation center, involving 500 FBI employees and 1,500 other officers from 27 agencies. The chaplain ministry continued for more than one year dealing with those who had PTSD symptoms. Instructor: Dr. Dan Tyler

E19 - Pulse Night Club Shooting

On June 12, 2016, at approximately 2:00 A.M., a self-radicalized Homegrown Violent Extremist (H.V.E.) entered the Pulse Night Club in Orlando, FL and carried out a terror attack that killed 49 innocent victims. The incident quickly transitioned from an active shooter event to a barricaded hostage-taker. During the incident, the suspect professed his allegiance to ISIS and stated he had enough explosives to level "several blocks." This presentation will provide an in-depth overview of the Pulse Nightclub terror attack. Details will be shared regarding response, challenges faced and operational decisions made during the incident, including victim extraction. Captain Goerke will also share lessons learned from the event to assist first responders to better prepare for critical incidents involving active shooters and mass casualty incidents. **Instructor: OPD Deputy Chief Doug Goerke**

E20 - Emotional Intelligence when Ministering as a LE Chaplain

The goal of this course is to help those serving as police chaplains with the practice and ministerial application of emotional intelligence when dealing with first, officers seeking chaplaincy aid, secondly, those victimized by crime and third, those who are in need and seek guidance in decision-making situations. By Emotional Intelligence we will use the Oxford dictionary definition of the term: "the capacity to be aware of, control, and express one's emotions, and to handle interpersonal relationships judiciously and empathetically". The course will center on the practice of Emotional Intelligence utilizing case study review and engagement.

E21 - <u>Leaving a Legacy or Vacancy</u>

Providing suggestions on the development of a plan of succession on leaving the chaplaincy. The value of leaving a program that will live on after your departure.

E22 - Intertwined Fabric: Implicit and Unconscious Bias

This course offers an understanding of implicit and unconscious bias intertwined and penetrated in various realms of society, professional, and personal arenas as it affects our understanding, actions, and decisions in an unconscious manner in our everyday lives. The challenge for chaplains is to remain objective both spiritually, personally, and professionally despite societal ills that have stained views of normal activity and/or behavior.

E23 - Concerns of Police Survivors (COPS)

The Impacts of Line-of-Duty Death training provides America's law enforcement agencies, officers and families an opportunity to gain information and resources regarding the impact of a line-of-duty death on an agency. This course will explore line-of-duty death trends across the nation and provide insight into the various ways a line-of-duty death impacts the families and agencies. This course looks in-depth at the detailed recommendations for handling Line-of-Duty Death and addressing the needs of families and co-workers. Also, the course will focus on best practices for departments for supporting families and co-workers during a line-of-duty death.

E24—Chaplaincy – The Essence of Community-Based Policing

Over the last several decades there has been an emphasis placed on Community-Based Policing. In this model of law enforcement, agencies become partners with other community organizations to work together to keep communities safe. Interestingly, chaplains often find themselves moving seamlessly between several "communities" and building bridges that can promote unity and cooperation. In this training, we will look at the way law enforcement chaplains can work with the law enforcement Community, Spiritual Community, Social Community and Neighborhood Community to enhance communication, security and quality of life issues.

E25 - <u>5 Laws of Personal Growth</u>

E26 - Officer Involved Shooting - The Aftermath

The International Association of Chiefs of Police (IACP) defines an officer-involved shooting as "a discharge of a service weapon by an officer during a hostile encounter or an accidental discharge, while onduty or off-duty, irrespective of injuries to suspects, officers, or third parties" (IACP 2015). It is widely accepted that officers involved in shootings (OIS) or other significant critical incidents require immediate support. Officers and agencies, and all those involved in investigating and making official determinations about officer-involved shootings, should become informed about the science of human performance factors that influence behavior during high stress, time-pressured, deadly force confrontations. Immediately after an officer-involved shooting (or another critical incident). OIS involved personnel should receive physical, spiritual, and psychological first aid (e.g., emotional support, reassurance, assignment of a companion officer to any officer who is directly involved in a shooting and is separated from others, pending investigative procedures) from qualified mental health and/or designated support personnel. **Instructor: Chaplain Mike Meyer**

E27 - Active Shooter Preparedness

Active shooter incidents are often unpredictable and evolve quickly. In the midst of the chaos, anyone can play an integral role in mitigating the impacts of an active shooter incident. Department of Homeland Security (DHS) aims to enhance preparedness through a "whole community" approach by providing products, tools, and resources to help you prepare for and respond to an active shooter incident. **Instructor: Mr. Marty Smith**

E28 - Spiritually Discerning the Defensive Killing of Another Human Being (Part 1) - E31 (Part 2)

Law enforcement officers are trained to stop an aggressor from physically harming or killing others. This means that they may have to kill another human being in order to stop them from inflicting harm. They knew this going into the academy and they know it now, but have they really discerned what this truly means? Being prepared to kill in order to stop an aggressor takes more than just being trained and being armed. It also takes a mental and spiritual resolve to act without hesitation and without regret. This requires removing any possibility that their faith or system of beliefs conflicts with the duty to respond with the use of deadly force when necessary. Although prepared originally for law enforcement officers, most of what will be discussed is also of significant importance for any citizen who is regularly armed with any type of deadly weapon for the purposes of self-defense and/or defense of others. This two-part class will highlight the importance of being prepared and working through the spiritual aspects or belief system issues associated with the possibility of having to end the life of another human being. The main purpose is to assist law enforcement officers in spiritual discernment so that any spiritual issues, known and unknown, can be addressed *prior* to encountering an incident where deadly force is needed.

E29 - Lessons Learned from the Surfside Condo Collapse

The tragedy in Surfside has become a defining moment for many throughout emergency services. In these months that have followed, much has been done to help us better prepare for future events. The chaplaincy has also been impacted. It became very clear that there was work to be done to better connect and coordinate fire chaplains across Florida. Surfside showed the distinct nature of the chaplaincy and the need to provide spiritual support in times of crisis. For many, great difficulty can create a crisis of faith which challenges long held spiritual beliefs. In addition, we saw how the practice of spiritual disciplines provided peace and comfort. In addition, we also observed the complementary role chaplains play alongside mental health professionals, peer support personnel, and K-9 peer support. Together, we provide comfort and care for the heart, soul, mind and strength of Florida firefighters.

We are reminded that we are not God. Therefore we must know when to back up and ask for help. There is a price to pay. Remember whom do you serve.

E35 - Generations in LE: Millennials & Generation Z Characteristics

E36 - Opioid Use Disorder, A Tool Kit

E37 - Honoring Law Enforcement Officers - How to Host a Successful Law Enforcement Appreciation Day

We are in a pivotal time, both nationally and throughout the world, with regard to how citizens see law enforcement. Chaplains will be challenged with the need for LE Appreciation. Recognizing and reaching out to police officers and their families is something that every Bible-believing church in America should be doing. Three times in the Romans 13, God refers to law enforcement officers as his "ministers of God". He specifies in verse 4 that they are His "ministers to thee for good." Without trained and dedicated law enforcement officers, there would be little or nothing good that law-abiding citizens could enjoy in their community. It wouldn't be safe to for them to live there. Together we will see how to organize, advertise, and support an annual "LE Appreciation Day."

E40—<u>Supporting the School Resource Officers (SRO)</u>

The role of a law enforcement chaplain is to provide support to our agency. Often, this is manifested in a vested interest in patrol activities; however, there are many other "specialty" assignments that can benefit from a relationship with chaplains. School resource officers traditionally find themselves alienated from their co-workers, trying to have one foot in the schools and the other in law enforcement. They spend most of their time working within the juvenile system which is different from the adult criminal justice system; therefore, their role is often misunderstood or underappreciated. They are on the frontline of protecting the schools from the worst type of community tragedy – an attack on a school – while trying to build a caring rapport with one of most vulnerable populations – children. SROs work a lot of hours but, are typically out of step with both schools and law enforcement. In essence, although they are constantly surrounded by hundreds of people, they often find themselves lonely and in need of support – and who is in a better position to provide this encouragement than a chaplain! In this training, we will take a look at the role of the SRO (from someone who spent several years policing in schools) and offer an insight into how law enforcement chaplains can provide friendship and assistance to this important specialty officer.

E41 - Spiritual Awareness, Emotional Intelligence and the 2022 Dysfunction Within LE Culture

The goal of this course is to aid the police chaplain in understanding the value of applying spiritual awareness, together with emotional intelligence when assisting members of law enforcement with the challenges of the 2020 uprising of dysfunctional police and community culture.

E42 - VIR TRA Tactical Simulator Demo/Training (1/2 Day Off Site Course Limited to 25 per Session)

(*Transportation Provided*) The VirTra Simulator provides users with a 300-degree, panoramic view of scenarios that immerse the student in realistic training situations that require force decision-making in real-time. The users will learn and practice using real weapons (modified for the simulator) to enhance skills in de-escalation, proper force decision-making, and mental rehearsal in critical incidents. The Simulator Course for Police chaplains will expose users to a sampling of the variety of situations encountered by law enforcement officers throughout the nation. The students will engage subjects in real-life situations and apply appropriate levels of force such as firing firearms, use of conducted energy weapons, utilizing chemical spray, or verbalization and feedback with the subjects on screen. **Instructor: Central Justice Institute Staff**

LIAISON COURSES

L01-R21 Introduction to Liaison

This course will provide comprehensive and detailed instruction in many of the basic elements of serving as a liaison between a department/agency and a chaplaincy program This course will include qualifications and duties/responsibilities of liaison personnel in different size departments/agencies and different types of departments/agencies. This course will also assist liaison personnel in relating to chaplains with differing ages, abilities, backgrounds, etc.

L02-R21 Leading Chaplains

This course will provide comprehensive and detailed instruction in assisting liaison personnel to lead the chaplains in their individual chaplaincy programs. This course will include instruction in the qualifications, duties and responsibilities of chaplains and how chaplains can be an overall asset to the agency. Details including chaplain credentialing, ride alongs and confidentiality are discussed at length.

L03-R21 Managing Chaplains

This course will provide comprehensive and detailed instruction in many aspects of managing chaplains. This course will include instruction on promoting the chaplaincy within your department, founding and defending a chaplaincy program and developing general orders for a chaplaincy program. This course will also help liaison personnel train, manage, discipline and deploy chaplains.

L04-R21 Policy and Legal Considerations

This course will provide comprehensive and detailed instruction in policies and legal considerations, primarily in regard to the laws of the United States of America. This course will include information on the first amendment and court cases that have set the standard for law enforcement chaplaincy including chaplaincy validation and special considerations such as mandatory reporting and privileged communication. State statute examples will also be discussed.

A01—ADVANCED COURSE-5 DAYS (2 PARTS A AND B)

(Monday—Noon Friday)

A01(a.) - ICISF Assisting Individuals in Crisis & Group Crisis Intervention (GRIN)

Crisis Intervention is NOT psychotherapy; rather, it is a specialized acute emergency mental health intervention which requires specialized training. As physical first aid is to surgery, crisis intervention is to psychotherapy. Thus, crisis intervention is sometimes called "emotional first aid". Designed to present the core elements of a comprehensive, systematic and multi-component crisis intervention curriculum, this course will prepare participants to understand a wide range of crisis intervention services for both the individual and for groups. Fundamentals of Critical Incident Stress Management (CISM) will be outlined and participants will leave with the knowledge and tools to provide several group crisis interventions, specifically demobilizations, defusings and the Critical Incident Stress Debriefing (CISD). The need for appropriate follow-up services and referrals when necessary will also be discussed.

This course is designed for anyone in the fields of Business & Industry Crisis Intervention, Disaster Response, Education, Emergency Services, Employee Assistance, Healthcare, Homeland Security, Mental Health, Military, Spiritual Care, law enforcement, and Traumatic Stress.

Part (b.) - ICISF Strategic Response to Crisis

Knowing what sequence of crisis intervention processes to use for which individuals or groups, at what times, and under what circumstances is crucial to all effective early intervention programs. The course will present essential information for the assessment of both crisis situations and the effects of critical incidents on people involved in those situations. Learn to create an effective plan of action to assist those in crisis and complete a series of exercises designed to sharpen assessment and crisis planning skills. Strategic planning and tactical decision making are emphasized, as are rationales for choosing one set of crisis intervention processes over another. This course builds confidence that crisis intervention-ists will make the right choices of interventions for the populations they are assisting under specific circumstances. This course requires previous training and experience. ICISF's "Group Crisis Intervention" and "Assisting Individuals in Crisis" (formerly Individual Crisis Intervention and Peer Support) should be viewed as prerequisites.

The class participants will become a peer support team and each participant will be assigned a permanent partner for long term, one on one confidential support.
