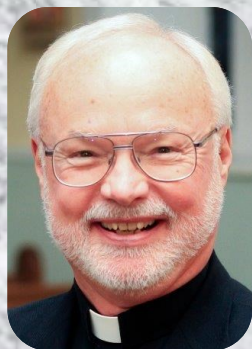

### Chaplains' Leadership

How do we chaplains lead aside from the traditional organizational chart?

Mainstream leadership models, even those forgoing spirituality per se, contend that leadership begins in inner space. The idea that the individual spiritual journey has implications for the larger community is not new, but one whose time has come. Each of us employ leadership of some sort on a daily basis. We lead from within but further delineate good leadership as extreme awareness of the interaction of inner dark and light, for fear leadership can do more harm than good.

Generally this rings true for chaplains, who acquaint themselves with the inner landscape and learn the language of leadership through theological inquiry, lived experience, CPE formation and continuous competency-building. I've collaborated and shared wisdom with chaplains consistently living out our call to servant, situational and transformative leadership — at different levels within a variety of care settings, whether operating one-person offices or as members of a larger pastoral/spiritual care department.

Some lead from behind, taking on the mentor-coach, advisory role. Pastoral presence encourages autonomy, potentially giving others permission to step into their own authority; often a precursor to making meaningful decisions during life's critical transitions.

While a certain willingness to stretch and risk in new directions is inherent in our call, leadership specialists and behaviorists alike subscribe to honoring who you are and what you desire in choosing a career path. Those of us for whom deep gladness and the world's deep hunger meet out in the field — those whose strength is in daily involvement with law enforcement officers, families, and staff — sometimes choose to decline formal leadership. But chaplains in the trenches often opt for advocacy and committee work to round out leadership by

helping articulate best practice, mission identity, and effectiveness.

Leadership seems so embedded in professional chaplaincy that opportunities may be unlimited, aside from the scope of charts.

In fact, leadership seems so embedded in professional chaplaincy that opportunities may be unlimited, aside from the scope of charts. In my status as a credentialed chaplain, I realize we enjoy a certain independence, which is a kind of niche.

Successful change is one of the biggest problems that modern organizations face. In our fast-changing world, the strategic imperative to change is often clear: Without doing things differently, our organization is unlikely to succeed, or last.

At its core, change leadership is working together to create a shared understanding of change required to execute the strategy, and how to best make it happen. But change-management research has demonstrated time after time that organizational change initiatives fail more often than they succeed, despite the resources put into creating change management processes.

I know that effective leadership is essential to successful change. But I also want ICPC to understand the differences in change between successful and unsuccessful change efforts. Our goal is to characterize ICPC to be change-capable.

Remember that, as ICPC continues to evolve over time, stability and change must coexist — which is not a problem to solve, but rather a polarity to manage. To help ICPC to achieve its full potential, we must acknowledge both poles simultaneously.

ICPC must continue to move forward in all aspects of our leadership to our local agencies that we serve to include change and progress in providing the most elite training and service to our agencies.

I look forward to seeing you at the Annual Training Seminar in Orlando, Florida July 18-22, 2022!!! We are Committed to Excellence!!!

At other times, it can be as simple as the anonymous maxim that caught my attention at ICPC training oh so many years ago: Don't just say something, STAND THERE.

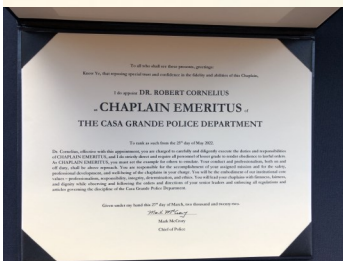

I was also able to minister to the police officers and firefighters that are there 24 hours a day helping people to find a place to stay and food to eat while they are displaced.

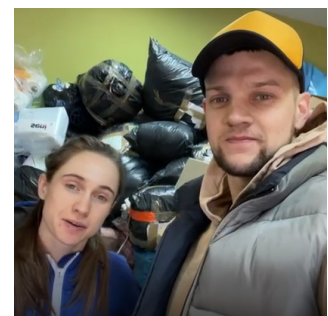
The picture of the little girl and her brother were from Ukraine and blowing bubbles was one of the most memorable times that I had.

# LIMITING LIABILITY IN CHAPLAINCY THROUGH PROFESSIONAL STANDARDS AND TRAINING

DR. CHRIS DOTSON, ICPC CHAPLAIN REPRINT FROM DECEMBER 2017

I had the opportunity to represent ICPC to the Tennessee Law Enforcement Accreditation Coalition, a network of federal, state, and local agencies that meets regularly to share information, ideas, policies, or procedures as they relate to professional standards and training. As I stood before this group of 85 law enforcement executives from across my state, I was reminded that in a day of increasing demands and limited budgets, effective volunteer programs, including chaplaincies, allow officers to focus on policing and enforcement functions by providing supplemental and/or support services. Volunteers, as you know, provide needed services that sworn officers may not have time to furnish, such as crisis counseling, chaplaincy, risk assessments, and even translation services.

Independent Sector estimates that police volunteers save their agencies \$24.14 for every hour worked. For example, Knoxville Police Department reported that their ViPS program logged 3,800 hours last year. At the above rate, that's a cumulated \$92,000 worth of donated police services. At the Morristown Police Department, our small unit logs enough volunteer hours to effectively replace one fulltime paid professional.

While 94% of law enforcement executives say that their volunteers add value to their departments, 81% of those same executives have related liability concerns. These officials recognize that investing in police volunteers can return substantial results, but they are not blind to the related costs – including liability. So how is the risk of liability addressed?

Fortunately, there are “Good Samaritan Laws,” such as the Volunteer Protection Act, that have been enacted to provide limited protection for volunteers. As long as they are acting within the express parameters of their duties and maintain proper credentialing, federal law affirms that they are not liable for their act or omission on behalf of the department. The only exceptions are the willful misconduct of the volunteer or any harm caused by the operation of a vehicle.

So as an extra measure, some agencies have chosen to classify their volunteers as “unpaid employees” or to pay their volunteers \$1 per year to ensure their department's liability coverage is extended to them. Other agencies simply have their volunteers sign an attorney-prepared waiver, effectively forcing their volunteers to maintain professional liability coverage out-of-pocket. With any coverage option, however, there remains the need to practically reduce liability.

Specific to chaplaincy, that means executives must first evaluate the constitutionality of their program. It is a common misunderstanding that having and funding chaplains violates separation of church and state, prompting many agencies to close the door to chaplains all together. That simply is not true, providing the three prongs of the “Lemon Test” are followed:

1. The program must have a secular purpose, such as victim advocacy or crisis intervention.

2. The principal effect of the program must be one that neither advances nor inhibits religion.
3. The program must not foster an excessive government entanglement with religion, e.g. favoring one denomination over another.

Meeting these three tests legitimize the work chaplains do for and on behalf of law enforcement agencies, reducing the grounds for lawsuits.

Furthermore, the International Association of Chiefs of Police recommend that agencies have clear guidelines in their General Orders. Policy should include a detailed position description, which addresses handling confidential information, time and training expectations, the wear of uniform items, and the risks associated with the position. Having prudent policies in place ahead of time, including a volunteer-specific disciplinary protocol, can protect agencies against liability should a volunteer operate outside of expected parameters.

The best way to limit liability, however, is to ensure that an extensive pre-screening process exists, including a thorough background check and verification that the candidate meets acceptable professional standards for the position. In chaplaincy, it is suggested that every candidate be ordained or commissioned by a recognized body, provide proof of ecclesiastical endorsement, have relevant and sufficient education and/or experience, and complete an approved credentialing program for chaplaincy.

Credentialing is a key component to reducing liability. It is never a good idea to turn an untrained chaplain loose on a police scene, no matter how qualified a pastor he/she is. That's where the International Conference of Police Chaplains comes in to play. ICPC is the industry standard in police chaplaincy, providing venues for professional development and training. Our credentialing program is designed to take a pastor's existing skillset and reapply it in a law enforcement setting.

# A Word About the Credential Process

RICHARD KASSEL, CREDENTIAL CHAIR

Members routinely ask about obtaining a Basic Credential Certificate after taking the 12 Basic Core Courses at an Annual, Region, or District Training Seminar.

Completion of the courses meet *part* of the requirements for a Basic Credential, it is *not* an automatic process.

## Credential Application Requirements

1. Member of ICPC
2. CEU and ICPC CEU hours/criteria:
  - **Basic**—3.5 CEU (ICPC-1.8 Basic Core Courses)
  - **Liaison**—4.0 CEU (ICPC-1.8 Basic Core Courses and .45 Liaison I, II and III)
  - **Senior**—15 CEU (ICPC-1.5); hold a Basic/Liaison Credential; 5 years as a law enforcement chaplain
  - **Master**—35 (ICPC-3.5); hold a Senior Credential; 10 years as a law enforcement chaplain
  - **Diplomate**—50 CEU (ICPC-5); hold a Master Credential; 15 years as a law enforcement chaplain; and 20 ATS/RTS Credits
  - **Fellow**—100 CEU (ICPC 10); hold a Diplomate Credential; 20 years as a law enforcement chaplain; 40 ATS/RTS Credits

The ICPC Credentialing Pamphlet (available on the front side of our website under the Credential Tab or [HERE](#)) provides definitions and additional details.

After review of the Credentialing Pamphlet, verify with the Academic Team to see if you meet all the requirements.

Once verified, you must apply for a credential by completing the appropriate application form from the ICPC website ([icpc4cops.org](http://icpc4cops.org))—Members Only Section—Credential Folder.

Members of the ICPC Credential Committee are eager to assist our members in obtaining higher levels of credentials.

There are committee members in each region of ICPC who conduct the interviews required for Senior and Master Credential Levels.

You will find them helpful as you seek any of the offered credential levels. Their names are listed on the website (Members Only Section—Committee Folder—Committee Roster). Please do not hesitate to contact them if you need assistance in preparing your application.

## Credential Certificates—Final Approval

Basic, Liaison, Senior, and Master Level—Certificates and pins are mailed from the ICPC Corporate office.

Diplomate and Fellow—Certificates and pins are presented at the ATS.

## Transcripts

Our Academic Team: Dr. John Transue, Academic Registrar and Mike Hendricks, Assistant Academic Registrar strive to maintain accurate records; however, it behooves each member to maintain a record of ICPC courses and/or other academic submissions.

Again, please consult the Credential Pamphlet for additional information regarding requirements for each credential level.

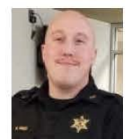

The ICPC logo is shaped like a five-pointed star of the early peace officer which was made famous by the Texas Rangers. Superimposed upon this is the more modern shield, the badge of office for those who have sworn to “shield” the public from those who would violate the law.

A field of blue, for truth, is surrounded by a circle of gold, for the unity of our chaplain family. Superimposed on the shield are the symbols of the Judean-Christian faith, signifying faiths of ICPC’s Founders, the six-pointed Star of David and the Cross of Christ.

A laurel wreath, a symbol of honor, surrounds the shield distinguishing the law enforcement profession. At the top of the shield is a rising sun signifying God’s Word.

Thus, we have both symbols of law enforcement and faith inextricably woven together and superimposed to symbolize our office as law enforcement chaplains.
