

Clarke and Tracie Paris place their hearts on their sleeves as they share research, studies, and their experiences, both personal and professional, which are the result of more than five decades in the EMS/First Responder/Police/ Military world.

Instructor: Clarke Parris served 27 years as a police officer with the Las Vegas Metropolitan Police Department (19 years as a supervisor) and is the President of The Pain Behind The Badge Training Seminars L.L.C. He has worked as a Vice/Narcotics Detective, Field Training Officer, Field Training Sergeant, Special Events Supervisor, Traffic Officer/ Sergeant (Motorcycle), and a Bicycle Sergeant on the Las Vegas Strip. **B2 - Death Notification** - This course will introduce strategic principles designed to prepare the chaplain deliver a more effective death notification.

Instructor: Chaplain Larry Smith holds a Master Level Credential and serves the Shelby County Law Enforcement Chaplain's Association and the Alabama Department of Public Safety. He is a retired pharmaca An ICPC certified instructor he has taught at the 2000 and 2010 Annual Training Seminars and at the 2010 Region Training Seminar. Larry has made numerous death notifications for the department he serves.

**B3 - <u>Stress Management</u>** - (includes segments on Burn-out, CISM and Post Shoot Trauma) - This course assists law enforcement personnel and chaplains in recognizing and dealing with all aspects of the Stress Management, Burnout, CISM and Post Shoot Trauma Instructor: Chaplain Tim Klerekoper holds a Diplomate Level Credential and serves as Head Chaplain for Des Moines Police Department, Tukwila

Police Department, Chaplain Coordinator for Federal Way Fire Department, Region Ten Chaplain for the Federal Protective Service, and Chaplain for the King County Sheriff's Department.

**B4 - Ceremonies and Events -** This course discusse the law enforcement chaplain's involvement in various public events and ceremonies including graduations, funerals, and public prayer.

#### E1 – Effective Chaplaincy and Local Church -

Presented from a Judeo-Christian perspective, this class will be more of a conversation than a monologue. It will explore the range of Pastoral Crisis Care (PCC) opportunities - from a car accident to an earthquake. By the end of class, each Chaplain will develop their own list of "The 10 PCC Basics" which they can offer to their local Churches. Pre-crisis training in local Churches can help build awareness & confidence; expand knowledge & skills; and increase their desire & availability to support & partner with their Chaplain in crisis related ministries.

**Instructor: Chaplain Pat Hammond** has 25 years experience in crisis intervention as a practitioner, trainer & advisor. Serving as a Senior Police and Fire/EMS Chaplain; FFC Chaplain Trainer; Disaster Responder and Trainer: and CISM Instructor. Lead Chaplain, City of Redmond Police & Fire Departments, Founder/Director in Response Team Director (in Life Clinic, LLC). Certified Trauma Services Specialist. He has Master's Degree in Education and Administration.

E2 - Aid Van: Since 1985, a highly successful and creative lay ministry that might certainly enhance your local fire and police chaplain program, to care (On-Scene) more effectively for the physical, emotional, and spiritual needs of family members who experience sudden events of crisis. This distinct vehicle and trained volunteer staff was first introduced following a suburban Seattle (Edmonds) underwater diving accident - to offer the family of the primary victim a private place to gather, away from an insensitive public and media. The vehicle also serves as an occasional "rehab" unit for emergency service workers.

Instructor: Chaplain Ken Gaydos became bivocational when he entered chaplaincy (fire and police) in 1973 while maintaining his career in radio and television broadcasting. He has been a pioneering influence in the planting of chaplaincy ministries within the Pacific Northwest and in select countries across oceans. His focus is in assisting fire and law enforcement agencies to care more effectively for victims and families who experience sudden crisis events. He was a member of the first FBI Chaplain's Class at Quantico, has received the Medal of Honor from South Africa's Fire Service Institute. He has previously served as ICPC's Region #2 Director, Area Representative and has received the John A Price Award.

#### E3 - Self Management and Stress Care - This

session will initiate a new twist regarding Stress Management - to focus on the need to experience selfmanagement that would hopefully evolve into stress care. The session will challenge the first responder care giver, liaison officer, entry level chaplain, veteran chaplain and pastor/shepherd care giver with evaluating the present posture and protocols for prioritizing their influence. We will explore the opportunities to enhance and develop a comprehensive self-management. A declaration of self-management will encourage us to experience and enjoy the fruits of self care.

Instructor: Chaplain Jim Crowley holds a Master Level Credential and serves as ICPC's Region #2 Director. Jim began his chaplaincy ministry at the invitation of the officers from the Vancouver City Police Department. Since 1993 he has provided pastoral care for the Bend City Police Department (OR State). In 2003 he began serving as a full time Chaplain with 12 Law Enforcement agencies in the Jefferson, Crook, and Deschutes counties of Central Oregon. He serves as the Senior Chaplain for Central Oregon Police Chaplaincy, a nonprofit organization providing support services to Law Enforcement, Fire and Dispatch agencies throughout Central Oregon. He is a COCISM team member and an Approved Instructor through the ICISF.

#### E4 - Early Involvement Chaplaincy Services -

Between orientation and graduation, the chaplain may be involved with a recruit class. This class will show the critical value and importance of early contact with future law enforcement officers as well as give practical tips on working with recruits.

Instructor: Chaplain Andy Kikuta holds a Master Level Credential and serves the Honolulu Police Department. As a certified department instructor, he teaches courses at the training academy for recruits, new sergeants and dispatchers. He serves ICPC as Region #9's Director and has received the John A. Price Award.

#### E5 - How to Help Officers Facing Legal Issues -

Police officers are often under the public microscope, and many times their actions are misunderstood by the citizens they protect. In some cases those officers are charged with a crime when they were simply doing their job. Such was the case in Spokane where Officer Karl Thomson was charged with excessive force. The impact of the investigation, trial, and post-trial on the police department was just like a line-of-duty death. Chaplain Alter will cover the incident, the investigation, the trial and post-trial, and discuss the role of the chaplain during each phase. You may be prepared for a line-ofduty death, but are you prepared if one of your officers goes to jail for doing his job?

"triggered" when they return to their law enforcement role. The young child struck by a car, entering a burning building, or the need to draw a service weapon can instantly transport the officer mentally back to the battlefield. The combat experience, lack of structure and camaraderie can also leave the officer feeling lonely and estranged from family and friends.

Instructor: Chaplain Robert Fiers holds a Master Level Credential, he is ICPC's Treasurer and serves the Indianapolis Metropolitan Police Department. He is also chaplain at Camp Atterbury and in that capacity he provides pastoral care to soldiers mobilizing and demobilizing in the Global War on Terror.

#### E17 - The Traumas of Law Enforcement Death -

**COPS** - This workshop will provide information on the proper response of a law enforcement agency to a line-of-duty death. Information will also be provided on the notification of survivors, funeral protocols, and the appropriate response of the law enforcement agency after the funeral. Additionally, the workshop will focus on appropriate methods for working with the survivors after the funeral is over.

#### Instructor: COPS President, Linda Gregory

#### E18 - Ethical Culture: From Misconduct to Corruption

- Regardless of the size of your department, each has an ethical "culture." The Chaplain can-and should-play a major role in the overall integrity of departmental personnel. This course addresses common pitfalls and patterns of misconduct, as well as signs of criminal conduct or corruption. By recognizing the signs of poor ethical judgment, the Chaplain can assist the department in promoting an environment of honesty, integrity and accountability.

Instructor: Chaplain Jim Gunnels holds a Master Level Credential and has been a Special Agent with the Federal Government for the past 28 years. He is currently assigned to the US Department of Homeland Security in the Dallas/Ft. Worth area. He began his work in police chaplaincy in 2000. Jim serves on the ICPC Ethics Committee. He has been certified by the Federal Law Enforcement Training Center (FLETC) as an ethics instructor.



A1 - Chaplain's Tactical Combatives - Designed for self protection in real life. Social violent assault scenarios, learned quickly and clearly. Chaplains serve victims and law enforcement, they are a part of the

family and culture of law enforcement; We even proudly wear the department uniform, which groups us in the profile of many who have a disdain for law enforcement (usually the criminal elements) yet we in many cases don't pack a weapon, concealed or otherwise, but can be the brunt of a misdirected assault. Like an officer being in a gun fight without a vest. Called to serve, but lacking appropriate protection. Thus the reason for this class. By the end of the 3 sessions the Chaplain will be armed with effective tools to protect themselves against violent, assault and aid in protecting loved ones and/or officers.

Instructor: CH LTC Mark McManus is a chaplain with the Billings Police Department (MT) and a Tactical Combatives Instructor/Certified Professional Trainer with ISSA. Mark is a 6 time Gold Medalist in the Montana State Games (Karate division) and a Member of Black Belts of the Faith International and holds belts in many different disciplines. He is also the Founder and Director Christ Corps Ministries.

A2 - Chaplaincy Self Defense - When we are exposed to the "worst of the worst" it is essential that we be prepared to handle the situation, not only professionally, but personally. If we are not well trained, emotionally and physically, to defend ourselves against the wear and tear of repeated exposure to traumatic stress, we will not survive in a healthy manner. This class will describe the physical and emotional impact of traumatic stress on the police chaplain, as well as identify ways to "fight back" and become more resilient to its impact. Like any good self defense class, practice makes perfect. Therefore, this class will offer opportunities to practice your emotional "self defense" moves and strategies.

Instructor: Dr. Kathy Thomas has worked in the field of mental health for over 25 years and maintains a private practice in Stillwater, OK. She has provided assistance following the attacks in Oklahoma City, New York and Washington, D.C. Facilitated and/or provided mental health consultation for over 90 Critical Incident Workshops. As a ICISF certified trainer she has conducted numerous critical incident response and training for the US Marshal Service, FBI, ICPC, Oklahoma Highway Patrol, the Oklahoma City Police and Fire Departments. She is on the Advisory Board of the Oklahoma Chapter of COPS, Inc. In addition, she provides mental health and support services for the national organization of COPS, Inc., including National Police Week, COPS Kids Camp, Spouses Retreats, Sibling Retreats and Coworkers Retreats.

E11 - Organizational Toxicity - The class will define organizational toxicity, review Peter Frosts "Seven Deadly 'Ins' of Toxicity," consider internal factors that contribute to toxicity and external manifestations thereof and understand how the dynamics of organizational toxicity can undermine efficiency and effectiveness in the law enforcement agency. The course will also consider ways in which law enforcement chaplains can address and mitigate organizational toxicity in their particular agency.

Instructor: Chaplain Steve Norden holds a Master Level Credential and serves the Dublin. Ohio Division of Police. He was recently appointed volunteer chaplain for the FBI Columbus Resident Agency. He serves ICPC as chair of the Public Relations Committee. He is the founding pastor of New Hope Church, Powell, Ohio, a ministry of the Reformed Church in America.



E12 - Insight into the Heart of a Police Officer: Knowing Who You Are Serving - Knowing who you are ministering to is critical to understanding how best to serve them. All police officers are different but they, also, all share a common imperative profile. Police officers must have an imperative personality in order to do the job safely. Although everyone has a tendency toward imperative thinking, the police officer's heart has a deep need to be in control. Learn about the imperative personality.

Instructor: Chaplain Fred Salerno serves the Royal Canadian Mounted Police and has extensively studied the Imperative Personality of Law Officers.

E13 - The Coroner-Medical Examiner ... and the Chaplain - Counselor - A basic lay introductory exploration into the critical profession of a community's Office of Coroner and/or Medical Examiner - and how an understanding of the offices' responsibilities allow for a significantly enhanced and more effective relationship with grieving family members around select events of death.

A "Gentle Caution": As we delicately, yet accurately attempt to introduce the strategic professional responsibilities of the Coroner/ME - please be advised that selected video segments will include graphic onscene, and morgue death investigations, in addition

to the clinical witnessing of a semi-edited postmortem examination - an autopsy.

Instructor: Chaplain Ken Gaydos see E2 Bio.

#### E14 - Oxygen for First Responder Marriages -

The Oxygen program is designed to help Chaplains strengthen their department marriages and work on tough issues in an environment that is fun and non-threatening. Designed to go beyond a one-time training session, the program includes critical elements that provide further training, on-going support, and resources. Couples develop a customized action plan and support system during the training.


Instructor: Noel Meador serves as the Executive Director for Stronger Families in Seattle, Washington. He is the lead author of the Oxygen for Your Relationship Seminar. He is trained in many relationship enrichment and counseling tools such as Prepare/Enrich and PREP. He has been a part of developing and producing two major relationship programs, Oxygen (Seattle, WA) and Lasting Relationships (Portland, OR). He is the creator and producer of Stronger Families LIVE, a live streaming broadcast that brings national marriage experts into the homes of couples seeking to strengthen their relationship and family. Currently, he is working with military couples on Joint Base Fort-Lewis McChord and has been asked to present about the Oxygen program at the AUSA national convention. Noel is passionate about working with the military, churches and first responder families.

E15 - The ICPC Credentialing Process - The ICPC credentialing process has undergone modifications, expansions and improvements over the past several years. It is vital for chaplains preparing to enter the credentialing process to completely understand the deadlines and requirements. Instructor: Chaplain Ron Alter holds a Basic Level Credential and serves the Spokane Police Department. In law enforcement chaplaincy for over 22 years, he has served as Senior Chaplain for the last 15. Overseeing the chaplain program, which includes another fulltime chaplain and 12 volunteers. Ron has provided assistance over the years, Chaplain Alter has helped five different officers when they faced court challenges.

E6 - Working Disaster Scenarios - This 2-part class is designed to better equip, empower, and encourage chaplains from any size department and any number of years serving as a chaplain. Part One will quickly discuss the basics of individual preparedness. With adult learning techniques, each section will be "taught back" to the class by the students. Part Two will get you as close as possible to the fire without getting burned! A tabletop exercise where each group will have a specific task or assignment to work through from selected disaster case study.

Instructor: Chaplain Mindi Russell holds a Master Level Credential and is the Executive Director of the Law Enforcement Chaplaincy Sacramento which serves 19 law enforcement agencies. She has served ICPC as Region #6's Director and currently is the North California Area Representative. Mindy has received the John A. Price Award.

#### E7 - Trauma, Grief and Loss - An interactive

presentation weaved with Phyllis' own story of her late husband who survived a car accident only to remain in a vegetative state for ten years. She tells of her journey as his caregiver while raising their three (3) children. Understand what resilience is and as a Chaplain how to lay the stepping stones in the first 3 hours, 3 days and 3 weeks for building resilience after loss. You will learn about grief responses, including the difference between bereavement and traumatic stress reactions. You will also learn how to talk about loss to different age groups and to help develop a support system around a person. You will leave with a tool packet to use on Chaplain calls to help build ongoing resilience to assist a person in living a whole life after a traumatic loss.

**Instructor: Phyllis Rogers, MA, LMHC** is a family therapist in Bellevue, Washington. As the Founder and Director of in Life Clinic she provides counseling in traumatic loss, marriage therapy, suicide, depression, anxiety, with a specialty in emergency service personnel. Phyllis also serves as a Chaplain for the Redmond Police and Fire Departments.

E8 - Raising Funds to Support Chaplaincy - Fund raising is neither the last nor the dreaded task of the full time chaplain. While this class will focus on fund raising principles, we will also look at practical ideas from grant

writing to the 'personal touch,' and give class members time to share their specific situations.

Instructor: Chaplain Dan Nolta holds a Fellow Level Credential and serves the Pierce County Sheriff's Department. Has been heavily involved in both personal fundraising and sponsoring his non-profit ministry. He previously served as ICPC's President; currently he does consulting and chaplain training when he travels as an International Ambassador.

#### E9 - Media Support for the Proactive Chaplain -

Can a website enhance effectiveness of a chaplain and chaplaincy program? You betcha. Your chaplaincy is busy taking care of people, building relationships, serving agencies, training for the future ... how do you create an engaging website presence? A comprehensive and customizable website is a strategic tool to help you build and maintain your chaplaincy and communicate what's important for your chaplaincy and community. A great website will include credible, original content. The information will be timely, kept up to date and well edited. Keep your design creative. Include media galleries of video, pictures, and audio. You might include a blog site or social networking accounts with Facebook, Twitter, and others.

Instructor: Chaplain Mike Dismore holds a Master Level Credential and serves with COPC. Mike is an ICISF Approved Instructor.



E10 - International Perspective of Chaplaincy - This course will discuss the various aspects of Chaplaincy internationally and ICPC's vision for the international scene. It will include international models of chaplaincy, chaplaincy mapping, resources and challenges facing the establishment of international chaplaincy programs.
