It is unbelievable how fast time is going by this year already. With the ATS being 2 weeks early, it will be upon us before you know it. Please do not hesitate in making your arrangements-especially your hotel arrangements. Most people don't realize that once you have gone past the cutoff date as determined by the hotel, they do not have to honor the conference rate and don't have to provide you with a room. If they do have rooms, it is often at a higher rate. Also, the room block we have specifies how many rooms you have each day. You cannot come in 4-5 days early and expect the get

the conference rate. If you contract for too many rooms nights and don't make your room block, then you have to pay attrition fees and run the risk of losing your free amenities—like meeting rooms, etc. So there is a lot more to it than you imagine!

ell, he's at it again! Yes, our beloved (and slightly crazy) Jim Powell is making another trek across the US to benefit the ICPC. Only this time the wily 'ole Kentuckian is riding a bicycle going diagonally the other direction- from San Diego, California to Caribou, Maine!

I had the opportunity to ask Jim a few questions about his upcoming trip and here is what he had to say:

Chuck: What made you decide to do another trip to benefit the ICPC?

Jim: First, I just love a physical challenge. The Seattle to Miami walk was definitely that and this is going to be just as tough but will not last as long. Second, I love the ICPC. I've met some wonderful people since I joined 16 years ago. I've received invaluable training that has helped me as I serve my department. Even though I got my "clock cleaned" by Mark O'Sullivan, a great friend, I've had the honor of running for Vice President of ICPC. Third, a fellow just can't sit there and do nothing!

Chuck: How was this route chosen and how long will the trip take?

Jim: I thought it would be good to do the opposite of the Seattle to Miami trip three years ago. This time go from the extreme part of California (San Diego) to the most northern point in Maine, finishing just north of Caribou. In other words make an "X" of the two journeys. We will go through California, Arizona, New Mexico, Texas, Oklahoma, Kansas, Missouri, Illinois, perhaps Indiana, Kentucky, Ohio, Pennsylvania, New

York, Vermont, New Hampshire and Maine. We hope to be back in Louisville in 5 - 6 weeks, rest for a couple of days and then continue on to Maine. Originally we had planned to take a route further north but Fox News will be giving us local coverage and they request we come through Louisville. Their affiliate in San Diego will show our start and feed it back to Louisville. They will also catch us along the way at various points. I cannot give you a definite conclusion date. I certainly hope to be finished in plenty of time for the ATS in Grand Rapids. I must be there because I have promised Bill Sanders that I will bring the set of state flags for him to use that were also used at the last ATS. I have been in touch with Chaplain Jack Poe regarding riding through Oklahoma and he has invited us to see the memorial that has been erected at the site of the federal building explosion.

Chuck: Who are the other riders going with you and who are they riding for?

Jim: There are 3 riders and the driver of the RV. They are **Bill Findley (52)**, a detective with the Casa Grande, Arizona PD, and a member of the ICPC. We will pick him up on our way through. Bill will also be riding to benefit the ICPC. He is the bike patrol officer for his department and will be valuable to us in many ways. Bill is getting in shape now by riding his bike 20 miles each day to and from work. **John Luken (62)** is riding to benefit the Special Olympics Program. He has a daughter with special needs. He is the president of a medical case management company and publisher of the medical consumer guide, <u>Navigating the Road to Recovery.</u> After hearing me preach in his church and tell of my intent to ride a bicycle coast to coast,

John signed on immediately to go with me! Ed Kalmey (67) is a people person guy. He is retired from Kraft Foods and is very active in Rotary. He is riding for a Rotary project called Safe Drinking Water - Worldwide. He has done a lot of backpacking in the western states. Larry Wooldridge (64) is a retired YMCA executive. Larry gave birth to the YMCA "Project Safe Place", an outreach and "safety net" resource for youth who need immediate help and safety. Presently there are over 15,000 Safe Places in America. Larry will be our RV driver but also plans on riding a little. His benefit is YMCA Project Safe Place.

Chuck: What does your wife think about this?

Jim: What wife? She left me while I was doing the Seattle -Miami walk! Just kidding, Chuck! We just celebrated our 48th anniversary and I'm afraid she's stuck with me now. She probably feels the same way my daughter felt about the walk when she said, "Dad is 2 French-fries short of a "happy meal!" She fully supports my efforts. However she wonders "why" am I doing this? But she had the same thoughts about the walk. I fully intend to be back in time to celebrate our 49th anniversary!

Chuck: What did you learn from your last trek that will help you on this one?

Jim: We are going to meet some very interesting people and see some wonderful sights. Savor them all. There was not one time on the walk that I felt afraid or threatened. Many times there were people who offered us help and support. Across eastern Washington there were days when we ran out of food and or water and would stop cars to ask for those things. They always came through. I learned that just because a name of a town is on the map, it doesn't mean anything is there! This came as a shock. Especially after walking into Dodge, Washington,

out of food and water and hoping to find a grocery or some kind of store so we could stock up again. There was one house!!!!! And the owner was kind enough to let us sleep in his yard and get water from a garden hose! The next day we walked on to Pomeroy, 13 more miles before we got anything to eat. I am going to spend more time looking up and out then down at the road, hoping to find a coin. Although I did find almost 1500 coins of various amounts, I am sure I missed other things by not looking at the beauty of this great country.

Chuck: What can ICPC chaplains do to assist you on your trip?

Jim: First, I would encourage all of them to remember us in prayer every day! Pray for our safety! Pray for good health! Pray that our particular benefits/charities will be blessed. Pray for our families while we are gone. Second, I invite every ICPC member to make a pledge or donation of at least \$25 to ICPC. If this happens, ICPC can realize at least \$50,000 of additional and much needed funds. I have personally created a list of 300 people here in Kentucky that I am going to contact and ask for their support. And I guarantee you that most of them will respond in a very generous and positive way!!!! Chaplains can ask their departments, their churches, their Sunday School classes to participate and make a contribution. Third, they can help with food expenses. This is now our largest expense since we have the cost of diesel fuel covered. If they could send us food coupons or gift certificates from restaurants that are nation wide, this would be a big help. We would divide the certificates equally among the group. I have written to KFC, (based here in Louisville) but have not received a response. I am going to write to Papa John's Pizza owner, who also lives about 8 miles from me. All they can do is say "no." Fourth, they can invite us to (Continued on page 11)





n November 5th, Vivian Panton, Head of Jamaica Constabulary Force Chaplaincy and I, departed our homes bound for Guatemala. Coming from two different directions we were to meet again in a country neither of us had ever visited. What awaited us was a wonderful experience of hospitality, open hearts and a very needy police service. Years of civil unrest, finally halted in 1996, resulted in a civil police still struggling to fight its way free of corruption and the old military ways.

The ICPC was invited into the country by officials of the Policia Nacional Civil through contact with Albert Mendoza, a former U.S. police officer, now an instructor in their national police training academy. The recently formed Values and Service Unit has been preparing to launch a chaplaincy program as another of its components. A Director of Chaplaincy, Eduardo Paz has been named and a structure is on its way to being completed.

Vivian and I were whisked around the country to visit main police stations (Comisarios) and small outlying stations with only a few officers posted. At every visit we found men and women eager for spiritual and moral help; commanding officers asking for help for their personnel.

In the former capital city of Antigua our traveling group split

into two with the Directors of Chaplaincy and Values services going to a meeting with some pastors and Vivian and I visiting a station of about 50 police officers. They were housed in old concrete buildings made over into barracks for them, a small station building and assigned a commander very eager to have help for his men. He stood with tears in his eyes telling us that he had asked for some pastors to come and provide spiritual and moral guidance for his men and women, many of the posted here from other parts of the country. No help had come.

After we prayed for him, we left the station to pick up the head of the Values and Services Unit and Chaplain Eduardo who had gone to a meeting with a pastor in the main part of Antigua. A half hour later we were back at the police station, willing pastor in tow. As we gathered around them for prayer, the pastor and the police commander were kneeling in the dirt, praying and jointly committing themselves to assist the men and women stationed at that police post. A very quickly answered prayer for help!

We expect to return to Guatemala to follow up on their progress and to assist in training Chaplains for the PNC.

Without their generosity, the trip could not happen.

Our plans are to leave from here on Sunday, March 25th and drive straight through to San Diego. Once there, we will start immediately on the ride. I have checked and in the first day, perhaps the second day for sure, we have a 4,000 feet rise in elevation!!!! Then we hit the desert of southern California as we head for Yuma, Arizona, 177 miles away!!!! Am I excited? You bet!!!! We are having several thousand brochures printed and we intend to pass them out along the ride. Regarding the route: Right now we plan on picking up Route 60 in eastern Oklahoma and follow it all the way through Missouri, into Kentucky and on into Louisville. It runs about 12 miles from my Another interesting note: The newly elected Governor house. of Ohio, Ted Strickland, is a personal friend of mine. We were classmates in both college and seminary and Ted has eaten lots of pizza at my house and slept on my couch when we stayed up all night "cramming" for final exams. It is pay back time and Governor Strickland owes me big time. I am going to try and contact him and as we pass near Columbus, try to get a meeting with him. President Hungler will be in on this. 
They plan to meet at the ATS in Grand Rapids for discussions on team development, logistics, etc.

BLACKETOR ICPC SCHOLARSHIP FUND



At the 2001 I.C.P.C. Annual Training Seminar, South Bend, Indiana, The Blacketor I.C.P.C. Scholarship Fund was established with an original endowment of \$50,000.00 by Dr. Paul G. Blacketor and his wife, Mrs. Sandra M. Blacketor.

The purpose of the Blacketor ICPC Scholarship Fund is to provide financial assistance to police chaplains seeking training under the auspices of the International Conference of Police Chaplains (ICPC).

ICPC Life Members, in a luncheon meeting at South Bend, voted to support the Scholarship Fund. Since that date 19 Life Members have contributed, with four making contributions each year. The average contribution has been \$100.00 with one member contributing \$1,000.00 and one member contributing \$500.00. Many thanks to one and all. We continue to need financial help to provide training for our Chaplains. The Scholarship Fund is currently engaged in a capital campaign to raise funds. The future looks bright.

The training level of Chaplains clearly indicates a need for an aggressive scholarship training program, for example, (Best statistics available as of 9/24/04) indicate 62 % with less than Basic Level Training.
