"Father Bill has also been there to congratulate officers on their marriage, the arrival of a new baby or other important events in their lives.

Father Bill has a heart for public safety that is too large to describe. After a distinguished career with the Fairfax Fire Service, Father Bill retired," Furr continued.

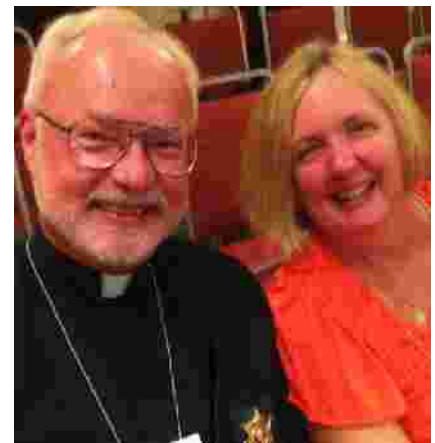

# Credentialing Deadlines Changed to Uniform Date

The International Conference of Police Chaplain Board of Directors approved a change recommended by Chaplains Leo Connolly and John Transue to make a uniform deadline date for Senior and above credentials.

The new date is Nov. 30 of the current year for credentials that are awarded at the Annual Training Seminar in the following year.

In addition, the BOD has changed the awarding of Senior credentials from being distributed at the Regional Training Seminars to being presented at the Annual Training Seminar.

“When it was decided to give them at the RTS several years ago, there were two dynamics,” Transue noted. “The first was that it would cut time at the ATS Banquet to keep the ceremony shorter. The second was that the Board wanted to see more families go to the Regional Training Seminars.”

“While it was a good idea, ensuring a credentials committee member was there to interview the candidate who might or might not be attending the Seminar, getting signatures from the credentials chair and the president on the certificate were insurmountable,” he concluded. Basic credentials have no deadline.

# Annual Training Seminar Memorial Service

Pomp and circumstances filled the ballroom at the Rose Hall Resort when the Jamaica Constabulary Force Honor Guard honored those law enforcement officers who made the supreme sacrifice to serve and protect the citizens of their jurisdiction.

Three different readers alternated in calling out the names of the slain officers. Chaplains from the countries or states of the fallen stood in honor when the name of one of their officers was pronounced.

The Honor Guard re-

versed their rifles to show that the officer called was now deceased. The audience appeared to be moved by the reverence displayed by the Guard.

At different times, the

entire Honor Guard marched across the room to change position.

We take great pride in honoring our fallen officers each year. This is an important feature of the ATS.

## The ICPC Memorial Bible Program

One of the very significant ministries of the ICPC is the Memorial Bible Program. On April 17, 1984 the first Memorial Bible was sent from the ICPC to the Miller County, Arkansas, Sheriff's Department. The ICPC had traditionally sent a letter of condolence to those who had lost a law enforcement family member in the line of duty. The Bible is sent to the chief executive of the department to be presented to the slain officer's family or placed in the department library.
