How Choosing Life Changes Lives



"Llegué al centro súper preocupado y confundida."—"I came to the center super worried and confused," she recalls over the phone. "Pero cuando dejé el centro el peso que sentía se había ido."—"But

when I left the center, the weight I felt was lifted."

Norma Gueta was thirty-two years old, mother of three, and pregnant with her fourth child as she drove herself to the abortion clinic about a year ago. Along the route from Arvin to Bakersfield, Norma prayed that God would send her a sign. She felt such a heavy weight as she contemplated what she should do about her unplanned pregnancy.

Norma's father, with whom she was living at the time, had threatened to take her children away from her if she became pregnant again. "I didn't want to have an abortion, but the fear of telling my parents that I was pregnant and losing my other children made me feel like I had no other choice. I prayed for God to show me what to do." When a woman from Lifesavers, a sidewalk counseling ministry, stopped her outside of the abortion clinic, Norma knew that God had sent her the sign she needed.

That sign from God is what led Norma to visit the Bakersfield Pregnancy Center, where she met with bilingual counselor, Patricia Santillan. "Cuando platique con la consejera mi sentí tranquila y con esperanza." — "When talking with my counselor, I felt calm and hopeful." Patricia encouraged Norma to receive an ultrasound, so that she could visualize and experience the little life growing inside of her.

During the ultrasound, Nurse Manager Teddie Scott noticed that Norma smiled and laughed as she watched the baby turn. "She was surprised by the child's development,"remarked Teddie. As she watched the tiny flicker of her baby's heartbeat, Norma was able to connect more deeply with her unborn baby. A wave of clarity and reassurance swept over the expectant mother, and she knew exactly what decision she needed to make. She remembers, "The ultrasound confirmed to me that I wanted to make the decision to keep my baby."

As Patricia and Norma kept in contact over the next several months, Norma was able to tell her parents about her pregnancy. She also returned to the center where she received maternity clothes, baby items, and even a bible. On September 9th, 2013, Norma gave birth to her healthy and beautiful baby girl.

Norma says that she wants others to know about the love and care she received at the Bakersfield Pregnancy Center. Her story is not unlike many others belonging to women who enter our doors every single day. Thoughts like "abortion is my only option" and "my life is over" plague the hearts of these women and their families as they struggle to find a solution in their crisis. Our center exists so that we might bring Light in the face of these struggles, and shed Truth on these fears and lies.

We celebrate and give thanks to God for victorious stories, such as Norma's. As an agency working under the direction of the One who chose to give us life, the Bakersfield Pregnancy Center aims to extend Christ's heart of unconditional love, grace, and hope to our clients, so that they might choose life for their unborn children.

As I begin my ninth year as Executive Director of the Bakersfield Pregnancy Center, I am in awe of the vision God has set before us!

Investing in the Vision for Life Financial Report for the Fiscal Year: 2013-2014

Thanks to the faithfulness of God, and the generosity of hundreds of donors large and small who have "caught the vision," the Bakersfield Pregnancy Center ended the 2012-2013 fiscal year in a sound financial position. Giving to the general fund exceeded day to day operating expenses, and several special project grants were received as well.

As a result, the center was able to remodel and redecorate key workspaces and client services areas throughout the office. The ultrasound clinic was also upgraded for the comfort and convenience of the nursing staff and their patients. A new church and community outreach coordinator was added to the staff to help expand our communication with our donors and collaborative partners.

The Board of Directors is grateful for the support of those who share their vision for addressing current and future pregnancy-related needs of our community through strategic planning, budgeting, spending and saving.

How the BPC Operates

The Bakersfield Crisis Pregnancy Center Inc. is a 501(c)(3) organization, so gifts to the center are-tax deductible in accordance with IRS regulations.

The center receives no federal or state assistance. All services are confidential to the extent allowed by law, and offered free of charge without regard to a client's race, religion, income, family status or nation of origin.

The BPC is an affiliate of Care Net, an association of over 1100 pregnancy resource centers across the USA and Canada. The center is also an affiliate of the National Institute of Family and Life Associates (NIFLA), and the Medical Institute, two nationwide, pro-life, educational organizations.

The BPC is a member of GuideStar and the Evangelical Council for Fiscal Accountability, and has established policies and procedures for financial and organizational management in accordance with ECFA guidelines. It's About Faith and Trust Meeting the Center's Strategic Goals Through God's Provision

In 2010, the Board of Directors of the Bakersfield Pregnancy Center adopted the First Choice Initiative, a five year strategic plan to guide the center into the second decade of the 21st Century. The initiative included the goal of making the BPC the first choice of women facing unplanned

pregnancies.

In the previous decade, the Bakersfield Pregnancy Center had grown and adapted in significant ways to the changing



needs of women in Kern County. In 2008, to accommodate expanding programs and increasing client numbers, the center moved to its present location, increasing square footage by 35 percent. Since then, a higher volume of ultrasound patients, expanded grief recovery programs and the addition of more services in Spanish have required us to become more and more efficient in the use of the wonderful facility God has provided. In addition, careful use of Internet technology has helped the center reach and minister to those in need, beyond the walls of our clinic building.

God has brought an incredibly gifted team of professional staff, volunteers and board members to the center. Along with them have come stronger ties to churches, community agencies, schools and the business community. Financial support to meet the needs brought through our doors has been faithfully supplied.

The numbers reported in the right column show the results of progress made under the First Choice Initiative. Client numbers overall have increased 22% since 2010, and the number of ultrasounds performed on women considering abortions is up 210%. In 2010, 92 of those women chose life for their babies instead of abortion. In 2013, 208 young lives were saved!

In light of the gains made in recent years, the BPC ministry team has updated its goal to embrace God's vision more fully: We want to help create a community where no woman chooses abortion as the solution to an unplanned pregnancy, because the needs of mothers, fathers and babies are met in dignified, life-affirming ways.

Our Vision for the Future

During 2014, the Earn While You Learn program, and a growing staff of male counselors, will enable the center to support and educate more men who are involved in pregnancy and parenting decisions. Longer hours, more nurses on sight and more resources for Spanish-speaking clients will also increase our capacity to reach those in need of life-affirming care and support.

Strategically designed billboards, radio, and television ads, new to the BPC's outreach strategy in 2013, will continue to be utilized for maximum impact. Secretary of the Board of Directors, Sheila Moore says, "We want potential clients and their support people to know who we are and where we are, so that when the time comes, they will look towards the BPC first!"

Whatever God has in store through 2014 and beyond, the BPC will rise to the challenge. We are partners in his life-saving mission. The future is as bright as the promises of God, and his promises can take us beyond any goals we set, into a place where faith and hope become reality!

Earn While You Learn Empowering Our Clients, One Relationship at a Time



Although the primary goal of the BPC is to create a community in which no woman chooses abortion as a solution to an unplanned pregnancy, the center has also served as a ministry to cultivate relationships with the women—and men—who enter its doors. One of the most exciting developments has been the Earn While You Learn program headed by Volunteer Coordinator, Laurie Ray. "The program allows us to provide for the practical and physical needs of our clients while requiring that they 'earn' these items through learning", says Laurie. The Earn While You Learn program encourages clients to educate themselves on parenting while earning Baby Bucks that can be used to purchase new or gently used items for their baby. Curriculum covers subjects from baby care, drug abuse, life skills and much more. Every center that has put this program in place has experienced growth, both in numbers and in relationships.
