A Note from Chaplain Jim Crowley, Northwest Region #2 Director


On Behalf of the Northwest Region #2 Team of Chaplains

TOPICS

LARGE GROUP SESSIONS

Chief Bob Vernon will Raise the Standard for our chaplains by challenging us about our Leadership, Integrity and Preparation/Training. What is it that he hoped for that the chaplains would bring to the Department when they showed up? Did they bring Calm to Chaos?

Noel Meador will enhance our understanding for equipping Marriages to be Renewed and Refreshed. We will gain insight and knowledge to help our First Responder Marriages and Relationships.

BASIC CLASSES

Each year we provide a number of the 12 ICPC Basic Courses. Our goal is to help new Chaplains to complete the Basic Courses in two years if the RTS is the only training they are able to attend. The Basic Classes offered this year will be:

B04 Ceremonies and Events – The class will provide the student with an understanding of the ceremonies and events used within Law Enforcement agencies and the role the chaplain plays in these events. Instructor – Instructor Chaplain John Transue

B08 Law Enforcement Family – The class will provide the student with an understanding of the law enforcement family unit, information on the law enforcement persona, an understanding of how officers go from altruism to cynicism, information on domestic violence in law enforcement, tools for ministering to the law enforcement family, communication skills for ministry to law enforcement, and resources for the law enforcement family. Instructor Chaplain Jim Crowley

B12 Sensitivity/Diversity – The class will provide the student with an understanding of what sensitivity and diversity is, an understanding of who we are in relation to other peoples or communities, an understanding of the police chaplain's role relative to diversity, recommendations of how to overcome prejudice, examples of universal human needs, levels of cross-cultural sensitivity, and ways to bridge the gap of diversity. Instructor Chaplain Tim Klerekoper

B09 Substance Abuse – The class will provide the student with an understanding of what chemical dependency is, identification of the thirty most common addictions, statistics on the impact of chemical dependence in law enforcement, information on the addictive personality, an understanding of the stages of the addictive process, and the chaplain's role for those with substance abuse issues. Instructor Chaplain Jim Fields

B10 Suicide – This class will provide the student with a general understanding of suicide, an understanding of how depression is related to suicide, an understanding how substance abuse is related to suicide, an overview of police suicides, and information regarding aftermath issues and general chaplain health and wellness. *Instructor Chaplain Bert McOueen*.

ADVANCED CLASSES

Spousal Support: Chaplains Pat & Lisa Ellis

This Class will give an opportunity to catch the Vision for an ongoing effective ministry for the Spouses of First Responders. It will also allow for Proactive Indicators to identify Weak and Strong Relationships. Our First Responders have an unusually high Divorce Rate and Relationship Difficulties that can cause the Officers to be unhealthy at best. They often resort to survival instincts that prove to be difficult for their careers. This Class will offer tools to identify these indicators and to put into practice a model for strengthening Spousal Relationships for our officers.

Disaster Preparedness Chaplains Preparation: Chaplain Mike Ryan

Chaplain Mike Ryan will provide a workshop for the chaplain to help them prepare and become better equipped to participate with a Disaster Response Team.

<u>Jim Crowley</u>

Jim Crowley has been a minister for the Church of the Nazarene since 1975. He has pastored in Washington, California, Illinois and Oregon. While pastoring in Vancouver, Washington he began his Chaplaincy ministry at the invitation of officers from the Vancouver City Police Department. It has been an honor for him to provide pastoral care for the Bend City Police Department (OR State) since 1993. He is now a full time Chaplain with Law Enforcement since 2003 serving 12 Law Enforcement agencies in the Jefferson, Crook, and Deschutes counties of Central Oregon. He serves as the Senior Chaplain for Central Oregon



Police Chaplaincy, a nonprofit organization providing support services to Law Enforcement, Fire and Dispatch agencies throughout Central Oregon. He has an earned Master's Degree and is a Central Oregon Critical Incident Stress Management (COCISM) team member and an Approved Instructor through the International Critical Incidence Stress Foundation (ICISF). He is the ICPC NW Region #2 Regional Director.

<u>Pat Ellis</u>

Pat Ellis is a career chaplain who serves the Kent (WA) Police Department, the Kent Fire Department, Maple Valley Fire and Life Safety, and Valley Communications 911 Center. Pat has been a chaplain for 10 years, 3 years as a volunteer while working as a youth pastor and the past 7 years as a career chaplain. Pat is a Certified Law Enforcement Instructor through the Washington State Criminal Justice Training Commission, a Level 1 Certified Fire Instructor, and a certified instructor for the ICISF teaching, "Individual Crisis Intervention and Peer Support," and, "Stress Management for the Trauma Service Provider". Pat currently teaches at



Bates Technical College for the Basic Fire Service Academy and at the CJTC for the Basic Corrections Officer Academy. He is a Member of Federation of Fire Chaplains (FFC), International Critical Incident Stress Foundation (ICISF) and the Association of Traumatic Stress Specialists (ATSS). Pat leads the Peer Support Team for the Kent Police Department, is the coauthor of the Washington State Fire Association Line of Duty Death Procedures, and serves as the lead chaplain of the National Fallen Firefighters Foundation L.A.S.T. Team for Washington State. Pat served 11 years as a youth pastor, is a graduate of Northwest College, and is married to his wife Lisa. They have 3 children and 3 grandchildren and live in Maple Valley, WA.

Jim Fields

Jim has been Police Chaplain for the Central Point, Oregon, Police Department for six years. He received his Senior Credentials at the RTS in Canon Beach, Oregon in 2011. He is a Certified Trainer with the International Conference of Police Chaplains. Jim is a graduate of the University of Redlands, Redlands, California, and has attended George Fox Evangelical Seminary. Jim has developed a basic survival training course for new chaplains designed to be given before they are able to receive their ICPC Basic Training. Jim is a recorded (ordained) minister with the NorthWest Yearly Meeting of Friends (Quakers).



<u>Tim Klerekoper</u>

Dr. Tim Klerekoper started as a chaplain in 1992 and currently serves as chaplain for King County Sheriff's Office, South King Fire and Rescue, Des Moines Police Department, and the Department of Homeland Security (FPS). He has earned a Bachelor's degree from Whitworth College, a Diploma in Christian Studies from Regent College, a M.A.C.M., a D.Min. from Faith Seminary, and a D.D. from Trinity Biblical University. He is currently Board Certified as an expert in traumatic stress from the A.A.E.T.S. Tim speaks and lectures internationally for several organizations. He has been married to Jan for 33 years and together they have two sons, two daughters-in-law, three grandchildren, and two foster sons.



Bert McQueen

Bert is a Certified Master Chaplain with the International Conference of Police Chaplains'. He is a recognized instructor with the ICISF for the "Small Group" CISM and "Individual/Peer Support/Crisis Intervention Strategies" and the National Guards "Trained Crisis Responder" and the "Pastoral Crisis Intervention" and the "Advance Group" CISM and "Suicide: Prevention, Intervention and Postvention" courses. He is the founder of several programs in Alaska; The Alaska Police and Fire Chaplains' Ministries, that provides Chaplains' Association, that promotes



standardization and professionalism in the law enforcement and fire chaplaincy, the Alaska CISM Teams Network, the Palmer/Wasilla CISM Team and the Anchorage CISM team that provide a complete program for stress management for the Alaska Law Enforcement and Rescue community and the communities they serve. He has served as a Police and Fire Chaplain in Alaska for thirty years, and is considered one of the leaders in the field of Emergency Services Chaplaincy and Traumatology in Alaska and has received national recognition for his leadership in Law Enforcement Chaplaincy and from the ICISF organization. Bert is also the LTC Command Chaplain for the 49th Readiness Brigade, DMVA, ASDF.

<u>Noel Meador</u>

Noel Meador serves as Executive Director for Stronger Families in Seattle, Washington. In this role, he is dedicated to strengthening families and marriages and ultimately, affecting the community at large. He has been a part of marriage outreach, pastoral counseling, and marriage education since 2001. Noel is the lead author of the Oxygen for Your Relationship seminar, which provides couples with tools and resources that help them promote authenticity and renewed vitality in their relationship. He received his Master's Degree in Education and is trained in many relationship enrichment and counseling tools such as Prepare/Enrich and PREP. He has



been a part of developing and producing two major relationship programs, Oxygen (Seattle, WA) and Lasting Relationships (Portland, OR), which have been taught to thousands of couples throughout the NW. He is the creator and producer of Stronger Families LIVE, a live streaming broadcast that brings national marriage experts into the homes of couples seeking to strengthen their relationship and family. Currently, he is working with military couples on Joint Base Fort-Lewis McChord and has been asked to present about the Oxygen program at the AUSA national convention. Noel is passionate about working with the military, churches and families in need and has begun training facilitators to send out to teach the Oxygen seminar throughout the community. Noel lives in Seattle with his wife and their three sons.

Mike Ryan

Mike Ryan has served as a police / fire chaplain since 1985, spending his first 18 years a chaplain for the San Francisco Police Department. He is currently a chaplain with the Norfolk, Virginia Police Department and the Amtrak Police Department. He retired from the United States Navy as a Senior Chief Radioman and has taught

He serves on the Education and Credentials Committees. He was appointed as the Academic Registrar in September 2009. He is married to the former Kathleen Huff. Bob Vernon, Law Officer's On Point columnist, retired from the LAPD after 37 years on the force. 
