 - a. Total Project Cost: \$1,148,549
 - i. This is the money to do the actual construction (material & labor) as well as the A/V system upgrade
 - b. Additional Costs: \$100,569
 - . This includes the risk insurance, interest payments during construction, and the 8% contingency
 - c. Total amount to be financed: \$1,249,118
 - 3. Loan Terms
 - a. 4.375%, 7 year arm/25 year term
 - i. Estimated payment of \$6,100/month
