- V. Treasurer's Report
  - a. Review of graphic annual summary provided by Jeff
    - i. Mission and Ministry Fund is in the negative so we have been borrowing from savings account
    - ii. Borrowing options are very limited as we can no longer borrow from the building fund.
    - iii. Action Item: Eric to draft letter regarding this issue and send out for review
  - b. May report – motion to approve by Al, 2<sup>nd</sup> by Andy. Discussion. Voted and approved
- VIII. Ministry Team Updates –
  - a. **Youth and Family**
    1. Reviewed charter. Ready for council approval
    2. Team members contacted and no changes to team
    3. Still need to make some goals for the fall
    4. NYA Pool = We will not be able to 'shut down' the pool and just have All Saints use it. The public will still be able to swim the night that we chose to have our gathering. Thinking of July 16<sup>th</sup>, 23<sup>rd</sup> or 30<sup>th</sup> = a Monday night. Swim time would be 6-8:30pm. Cost would be \$35 for groups of 10 and any additional attendees would pay \$3. So if we had 42 people attending we would pay \$146 (35 x 4 (4 groups of 10) = 140, plus 2 people at \$3 each). Date chosen is July 16<sup>th</sup>.
