Approving Minutes from March 13, 2021 meeting

Old Business

9:30 Order of the Day / Church of the Brethren Mission and Ministry Board Strategic Plan / Compelling Vision

David Steele and Paul Schrock joined the board Zoom meeting to lead the discussion regarding the new Mission and Ministry Board strategic plan/compelling vision. The goal of the plan is for the Jesus in the Neighborhood focus to drive the work not only at the brotherhood level and district level but each local congregation.

The Southern Ohio board discussed putting together a revised strategic plan now so that we will need to select a district executive. Todd will bring the leadership team together to establish how to proceed and will report at our July meeting.

- Racial Justice Team / Racial Justice Query: The team for the district is absolutely amazing. They are appointing a subgroup to develop the actual query with the goal of having it ready for district conference in October.
- Plan for saving or getting rid of District Documents procedure: The committee has yet to meet.
- District Conference October 8/9 will be a virtual meeting at this time. Tim and Audrey Hollenberg/Duffy, pastors of the Oakton Church of the Brethren in Vienna, VA will be leading the worship on Friday evening.
- Updating district computers: Dave was thinking that since there will be a transition to a new District Executive should be able to select a system. Dave would like to suggest getting a new hard drive that he will purchase for the computer he has if he can then keep it when he leaves. Mary needs a new computer, and she intends to stay. Karen has decided to purchase a new computer for herself with the request that any money that would have been used for her computer be set aside for the person that replaces her. Mary will have \$ 2000 set aside for her computer. If the amount is more than this, the leadership team can review it and make the decision about increasing the amount.
- Search Committee for District Executive: The committee will be comprised of the board members, congregational members, and Nancy Heishman. Karen Dillion, Nick Beam, Laura Brown, and Todd Riesh have volunteered for the search committee as board representatives. Several congregational individuals were suggested. Todd will contact them about serving on the committee.
- New Position in the District: Proposal was made by Lucas Keller from the Racial Justice team that a new position for the district as a Justice Ministry Coordinator. This will be on the agenda next meeting. Todd will send the proposal to the board members for review prior to the meeting.

#### Commission Reports

- Shared Ministries  
Karen Dillion filled in for Ann Stackhouse. BDM is focusing on the Dayton area. They have opened the overnight lodging sites so now people from other areas can participate. Young Adults have several events planned for this summer. They are hoping to have in-person activities. Pat Krabacher is working as a liaison with/for Nigeria. Racial and Climate justice groups have become vital parts of the Shared Ministries Commission.
- Connections The commission has not been meeting. We need to determine if this commission needs to continue. We may want to restructure and blend this group into one of the other commissions as we have expanded the work focus of other commissions.
- Resource Development
