257.624B1 – Alcohol – Possession by a Minor in a Motor Vehicle	Misdemeanor	<ol style="list-style-type: none"> <li>1. 90 Days and / or \$100.00</li> <li>2. Community Service</li> <li>3. Substance Abuse Screening</li> </ol> <p><i>Use Note: This charge applies equally to drivers and passengers.</i></p>
436.17011-A – Alcohol – Selling / Furnishing to a Minor – First Offense	Misdemeanor	<ol style="list-style-type: none"> <li>1. \$1,000.00 and 60 Days</li> <li>2. Plus Community Service</li> </ol>
436.17011-B – Alcohol – Selling / Furnishing to a Minor – Second or Subsequent Offense or Notice	Misdemeanor	<ol style="list-style-type: none"> <li>1. \$2,500.00 and 90 Days</li> <li>2. Plus Community Service</li> </ol>
436.17012 – Alcohol – Selling / Furnishing to a Minor – Causing Death	Felony	<ol style="list-style-type: none"> <li>1. 10 Years and / or \$5,000.00</li> </ol>
436.17032-A – Alcohol – Use of Fraudulent Identification by a Minor	Misdemeanor	<ol style="list-style-type: none"> <li>1. 93 Days and / or \$100.00</li> <li>2. Secretary of State to Suspend Driver’s License</li> </ol>
