# **Ministry Reports**

### Worship and Music

The Worship and Music Committee is responsible for the liturgy, music, and drama throughout the seasons of the church year. It oversees the functionality, maintenance, lighting, sound and liturgical arts of the Sanctuary area.

Sub-committees are tasked to provide ushers, greeters, communion servers, liturgists, acolytes, and audio/video operators all essential to cohesive worship services. Fresh flowers in the entry are provided by congregants via a sign-up calendar in the church office, or by the committee as otherwise needed.

With the 2020 COVID-19 pandemic, worship was transformed from in-person to online using Facebook Live Streaming. It was decided to have the livestream Sunday worship services broadcast live and not prerecorded. During COVID-19, the Church was closed to in-person worship, with only the worship participants in the Church building during the Sunday services. To enable a strong live steam Sunday worship experience, additional audio/visual equipment and software was purchased through donations from the Presbytery of the Cascades and Valley's Memorial Gifts.

The audio/visual team, with the assistance of Bob Rasmussen, implemented the Open Broadcaster Software (open source) to capture camera video, soundboard sound and computer output providing the opportunity for Valley members and friends to continue to enjoy live worship remotely.

Prominent celebrations include Epiphany, Lent, Pentecost, Advent, and Christmas. As well as All Saints Sunday commemorating those who passed away in the past year, as well as Kirkin' o' the Tartan honoring our Presbyterian Scottish heritage.

Acolytes light the Christ Candle and pour the baptismal water during the prelude at each worship service. Communion is served by intinction on the first Sunday of each month. During the COVID-19 pandemic, Valley church celebrated Communion remotely with the congregation during the first live stream worship services of the month.

Valley continues to be blessed with a vital music program, which includes the Sanctuary Choir, Armonia Youth Choir, Melodia Children's Choir, Cherub Choir, New Spirit Ringers and Royal Ringers. During the COVID-19 live stream worship, soloist vocalists from Valley's Sanctuary Choir were used to lead the singing during worship. Occasionally, other singers (e.g., youth) and instrumentalists also participated in the service.

Worship hymns and music are chosen by Pastor Jeff Binder, in collaboration with the Music Selection Committee which includes Valley's Music staff and a subset of the Worship & Music Committee members.

For Good Friday, we continued with displaying the Stations of the Cross throughout the Sanctuary for visitation throughout the afternoon.

The committee is ever-exploring new ways in which to enhance our worship of God. We welcome any suggestions for our consideration.

### Finance

The Finance Committee is responsible for overseeing the financial operations of Valley Community Presbyterian Church. This includes tracking assets, liabilities, fund balances, program and non-program revenues and expenditures. In addition, the Finance Committee coordinates the annual Stewardship campaign for Valley. Due to COVID restrictions, our 2021 campaign was conducted 100% remotely.

Valley received \$427,902 in 2020 adult giving contributions, a small decrease from 2019 but more than 2020 budget. The Finance Committee would like to thank our congregation for its ongoing commitment to Valley and its mission despite the difficulties of 2020.

The most significant condition affecting Valley and our finances was restrictions imposed by the coronavirus: Sunday Worship rolled to a virtual basis, and our building was closed except for essential services. That meant our Preschool could no longer operate, a condition that persists to this day. In recent previous years, the Preschool generated revenue in excess of the cost of operations. That was of course impossible in 2020, and we anticipated a substantial expense in this area once the restrictions became clear.

Thankfully, Congress passed the CARES act in the spring. A portion of this legislation called the Paycheck Protection Program (PPP) was designed to encourage employers to keep staff on the payroll. Valley received a PPP forgivable loan as reflected on our Income Statement. A significant portion of the loan proceeds was used to help pay for the cost of preschool salaries through (what we hoped would be) a partial shutdown ending by summer.

As of February 1, 2021, the Stewardship Campaign has received 106 pledges totaling \$293,476. This is 18 fewer pledges and approximately \$80,000 less than last year. Using historical trends, the Stewardship Committee thus forecast 2021 adult giving to be \$40,000 less than 2020 as reflected in Valley's 2021 budget.

The church has debt for the first time in many years. This debt, in the amount of \$93,800, will be forgiven when our lender processes our PPP loan forgiveness paperwork.

### Memorials and Gifts

The Memorial Gift Committee oversees the gifts given to Valley Community Presbyterian Church as memorials. The Committee serves as a ministry of the Finance Committee of the Session.

Contributions to the memorial fund are received in honor of members and friends of the church. These gifts are used to enhance the life of the church and its buildings and grounds.

There were no memorial fund requests in 2020. There is still money in the memorial fund for youth, music ministries, the library and undesignated funds that can be used to enhance the life of the church and its buildings and grounds. As the overseer of the memorial fund the Committee is responsible for informing the designated ministries of the church to be aware of the funds available to them.

### Facilities/Safety & Security

Valley's Facilities/Safety & Security Ministry is responsible for maintenance of the church building, Youth House, residence and grounds, as well as three rental properties on Cedar Street and the TriMet parking lot on Laurelwood. The-committee identifies, assesses, approves and coordinates all repairs and improvements. Work is performed by committee members when feasible, and qualified contractors when needed- Proactive maintenance is our primary objective.

#### Significant 2020 projects

• <u>Stained Glass</u>: Our stained glass window preservation and restoration project took place in August after six months of extensive research, contractor selection, and generous fundraising. This deferred and long overdue preservation assures that their legacy will endure for generations to come.





• <u>North Staircase:</u> The north exit stairs from Davis Hall to the courtyard were replaced. This required custom fabrication to conform to the existing base and comply with fire codes. This was a deferred Property Improvement (PIC) project due to funding.

• <u>Davis Hall Chairs:</u> Roger Rees fabricated attractive and structurally sound steel chair carts for Davis Hall. As a result, chair carts now require less space and are easily movable. All chair cushions were cleaned.





• <u>East Entrance Sign</u>: A church name sign was mounted to the entrance canopy over the east parking lot entry to the church. This was also a deferred PIC project.

• <u>Sewer Line Replacement:</u> The 1947 discharge sewer line from the Youth House/Residence was replaced due to failure in grading and disintegrating concrete piping. This was an unexpected unbudgeted project. Alpha Environmental provided the materials and labor at a deep discount.



- <u>COVID-19 Updates:</u> With onset of COVID-19 pandemic in March, extensive research was undertaken to compile statistical data for occupancy, habitation, building access, sanitation, accountability, tracing, ventilation, air circulation & filtration, and much more. Facilities worked in concert with the Virus Task Force and Worship & Music.
- <u>Landscape Maintenance</u>: JSL Landscape's services was budgeted for 2020 providing groundskeeping and irrigation services throughout the year.
- <u>LED Lighting</u>: Approximately 350 LED tube lights replaced all fluorescent tube lights throughout the church (except Davis Hall). Energy Trust of Oregon provided these tubes at no charge.
- <u>Lower Conference Room:</u> This room was refurbished with new paint and new conference table chairs.
- <u>Hall Stairs</u>: First floor hall stairs were carpeted. The original rubber stair treads were breaking apart and hazardous. This otherwise simple project required necessary asbestos-based mastic removal and decontamination at considerable expense.
- <u>Rental Properties:</u> An assessment of required rental property repairs was presented to Session. As a result, a task force was formed to research the viability of these properties as well as the necessity of retaining the lower parking lot.
- <u>Safety & Security:</u> Performance Systems Integrated (PSI) was contracted to consolidate and coordinate fire and security testing, documentation and maintenance previously performed by various agencies.

Facilities is continuously striving to make Valley a welcoming, comforting, and safe place for all those who enter our church campus.

### Valley Community Presbyterian Church Foundation

Valley Foundation has an investment account to use for our church's needs. All Foundation Trustees are members of Valley Community Presbyterian Church and elected by the congregation. This account sets aside money to be spent each year, while keeping the principle intact. By rules set forth in the bylaws, these funds are to be kept separate from the general fund. The interest and donations the Foundation receives are used to fill requests from Valley.

In 2020, Valley's Foundation funded one request for financial support amounting to \$2,000.00

#### The following request was funded:

• \$2,000.00 was paid to the Stained Glass Restoration Fund. This money was used to refurbish the Church's stained glass windows.

Valley Foundation is pleased to be a continuous resource for the church and its programs.

### **Mission Committee**

Valley's Mission Committee continued to meet the needs in the local area, the region, and around the world during this very challenging year. Thanks to the generosity of the congregation, money and donated items were collected throughout the year to meet local and far-off needs.

Our committee needs new members for some of our activities. If interested in participating in this very satisfying work, please contact Connie Brenner.

**Items collected** during the year included over 2,200 pounds of food for St. Matthew's food pantry and pickup and car loads of Styrofoam for recycling. A number of household items were collected for donations to Love, Inc. Because of the pandemic, Valley participated in no **Habitat for Humanity** builds this year but stay aware of opportunities in the coming months for this important activity! A number of volunteers helped distribute food at **St. Matthew's Lutheran Church/SCAT Food Pantry** to alleviate hunger locally on the 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> Wednesdays of each month. If you're interested in volunteering for this outreach, please contact Janet Adkins. Food and household items went to the **Grass Roots Church** for the Reverse Advent Calendar collection.

Other Mission endeavors around Valley include: The **Salvation Army Giving Tree** which was done on a remote basis in 2020. Valley continued to provide space for blood donations for the **American Red Cross,** and supplied drivers for **Meals on Wheels**. Valley provides office space to the **Rev. Jenny Hale** and **Second Home. The Earthcare Team's** previous activities qualified Valley as a PCUSA **Earthcare Congregation**, and we continue to look for ways to save resources. Several family groups participated in the SOLVE beach cleanup in August at Cannon Beach and Manzanita.

A Minute for Mission was offered during worship on the second Sunday of each month. **Special PCUSA Offerings** were received four times during the year: **One Great Hour of Sharing,** Pentecost Offering, Peacemaking Offering, and the **Christmas Joy Offering**, totaled \$8,085. Portions of the Pentecost and Peacemaking Offerings are retained by Valley and used for work in our local community (including Second Home) or specified gifts to national/international projects from the Presbyterian Giving Catalog that support family nutrition, displaced students, and youth agricultural training.

**Presbyterian Partnership Giving**, to support denominational outreach, received \$8.000 from Valley's budget. The **Theological Education Fund**, supporting the education of pastors for reformed church congregations, received \$500. From Valley's Mission budget, \$879 was spent to support Care to Share (a local social service agency), and programs from the Presbyterian Giving Catalog. \$1,300 was received in the **monthly Cents-Ability offerings**, (\$800 less than 2019), with \$692 sent to **Care to Share**, and \$1,050 to the **Presbyterian Hunger Program**. Although we're unable to collect coins on the second Sunday of each month while not worshipping in person, Cents-Ability is one of the options on the Valley website's online giving page.

Two of our usual activities had to be cancelled for 2020: Mission Market and the Bread for the World bake sale. We did collect \$750 for Heifer Project International during December. Soup (or another hot meal) was provided monthly at the **Bud Clark Commons** in downtown Portland. Prayer shawls and purple hats for Providence Hospital newborns were knitted and contributed. **Dining for Women** continued to hold monthly meetings (by Zoom) to hear about and help support programs that work to improve the situation of women and girls around the world in underserved areas.

#### **Committee process:**

Grant application deadlines remain April 1 and October 1. The committee met in April and October. After approval from the Mission Committee, the proposed grants were ratified by Session in May and November. Award letters and checks were sent in June and December.

### **Mission Endowment Fund Investment Committee**

The genesis of Valley's Mission Endowment Fund began in 1949 with a gift of over \$200,000 in closely held stock by a former Valley member and his wife. The donor designated the gift to be used only for "mission purposes and not for salaries or operating expenses at the local congregational level." Accordingly, the fund is held in a separate designated account on Valley's books to which the original donor hoped that "the gift itself would inspire others to add to this fund." Current investments are broadly diversified in market traded assets with about two-thirds in the equity sector. At December 31, 2020, the balance in the Endowment Fund was \$497,983, an increase of \$41,645 (9.12%) for the year.

Semi-annually, the MEF Investment Committee determines the dollar amount under the gifting formula  $-2\frac{1}{2}\%$  of the fund's nine quarter rolling average -a 5% annual payout. Mission requests are reviewed by the Fund's gifting committee (co-chaired by Carol Powers and David Marquis) and then recommended to Session for final approval. In 2020, the Fund awarded gifts of \$21,500 and has provided for gifts of about \$452,141 since the year 1999.

The MEF Investment Committee meets quarterly to review market trends, results and the asset composition.

### Membership and Outreach Committee

#### Highlights

The Membership Committee consists of a small, dedicated team who are working to open Valley's doors to the community and to bring new people into the church. We are also working to facilitate cross-church activities so many groups can participate in projects.

The Membership Committee activities include the following when not under COVID-19 restrictions:

- Personal Greeters Program so people entering the church receives a personal greeting. Thank you volunteers at the front and East doors!
- Provides a First Time Visitor gift for each person identifying themselves.
- Each new worshipper who provides contact information was contacted by a Pastor and/or a Membership Committee member.
- Holds "Welcome to Valley" luncheons to answer questions about VCPC and how we can best serve their needs.
- Conducts New Membership Classes with Pastor Jeff to prepare people for the benefits and responsibilities of membership. This was done in 2020 via Zoom. We have people waiting for church services to resume to formally join the church.
- Calls special Session meetings to accept new members. New members are introduced to the congregation at a worship service and a reception following.
- Coordinates/writes the New Member feature articles in the Valley Messenger.
- Revises and maintains New Member Packets for those joining the church.
- Teams with the Worship and Music Committee to sponsor the Blessing of the Animals service in July.
- Teamed with the Fellowship, Facilities, and Worship Committees along with others to cosponsor Valley's Third Annual Outdoor Christmas Tree.

After retirement of elder, this committee assignment is not yet filled for 2021. Please review the activities above and see if God calls you to serve to welcome new people to Valley Community Presbyterian Church.

### Communications (a Membership Subcommittee)

The Communications and Social Media Committee reformed in 2018 as a subcommittee to Membership. It coordinates and supervises external and internal church communications and public relations events. It administers the Valley website (valleycommunity.org), Facebook page and oversees the publication of *The Messenger*, twice weekly e-blast, and the weekly church bulletin along with specialty items such as the church membership directory, the annual report, etc. The coordinator also communicates activities to those outside our church walls by use of our Nextdoor account and with communications with the apartment complex adjacent to our building. All church communications route through the Communications Administrator (Angela Graham) before publication or distribution to ensure consistent messaging, to aid proper identification, and to act as a clearinghouse.

At Valley Community, the Vital Congregations Initiative committee is a seven-person team that meets once a month to assist Valley Community to evaluate its strengths and weaknesses and to evaluate how to best plan for our future inside the goal listed above.

Originally designed as a two-year process, the Vital Congregations Initiative calls for a time of prayer and thoughtful consideration. It is an opportunity to stop and evaluate our world, our local community, and our strengths and resources as a local Faith community. ### Virus Task Force

The COVID-19 Task Force began meeting in spring 2020 for the purpose of creating church policies and procedures that are in full compliance with the governor's orders and the Oregon Health Authority and that are tailored to the needs of Valley's members. The orders from the state are constantly changing, which requires ongoing adjustments from the committee.

Here are some examples of the decisions from the committee:

1) Having only live-streamed worship services at least until Washington County is out of the extreme risk category. Many steps have been taken in order to be prepared when it is time to resume in-person worship and other group meetings. There are signs that indicate maximum occupancy of various church rooms as calculated according to the OHA metrics. Hand-sanitizing stations are strategically located. Seating will be carefully spaced out and mask wearing is mandatory. The ventilation system of the church has been updated. Singing by anyone other than the designated worship-leading singers will not be allowed in the sanctuary.

2) The preschool is preparing to open in April; detailed procedures and policies, following all OHA Early Education Guidelines, have been approved by the committee.

3) The Youth Group and Confirmation Class are meeting in the gym, in groups with no more than 10 individuals, according to the OHA Guidelines for Youth.

#### Valley Children's Mission Statement

Using Christ's love as our example, we seek to INSPIRE, CELEBRATE & EQUIP children and youth as together we explore and live out our relationship with God. We accomplish this through worship, education, fellowship, mission and service

#### Children's Ministry:

#### Kids-Night-Out - at Valley (K.N.O)

This indoor event is from 5:30-8:30 p.m. (pre-K-5<sup>th</sup> grade) once a month on a Friday night. Involves: Indoor recreation, crafts, bible message, movie & dinner. coincides to a certain theme. <u>Two</u> KNO events happened just prior the COVID-19 shut-down. <u>30</u> children in January came and we had <u>23</u> children in February. <u>52</u> children are on our KNO Roster who started coming back in 2020 before COVID-19 hit.

#### Kids-Night-In - at Home (K.N.I.)

After March 2020 we changed up the program and prepped "Faith & Family Fun-Bags" for pick up at church under a decorated canopy – usually on a Friday and Saturday. Families RSVP'd and also had the option to have their bag(s) delivered as well. We welcomed our surrounding community to grab one when they were out as well! It was a hit and tapered off when school started.

532 KNI Fun-Bags were given out in 2020 which averaged out to 76 bags through our seven events. \*April: 141, May: 84, July: 89, Aug: 71, Oct: 50, Nov: 59, and Dec: 21. 75-100 bags were usually prepped for each event with exception of April. Extra bags were given to our local apartment communities, shelters or fire stations to be handed out to children. Our Family Fun-Bags were a hit starting in the Spring and began to taper off as school got closer.

#### Sunday School

<u>Five</u> children (K-5<sup>th</sup>) were welcomed up through March 1 by our Children's Director and volunteer staff. <u>Six</u> children (Nursery-Pre-K) were welcomed by our Nursery Care Coordinator and volunteer staff.

#### Weekly Sunday School Lessons

Sunday School lesson plans have been going out in our Friday's e-blast since March 2020. This includes two Valley Kids Worship Bulletins for 1<sup>st</sup> through 5<sup>th</sup> graders, and one for children 3+ years. Also included is a weekly Bible message to the children, age appropriate Bible story video, craft, and/or a Bible story coloring book. All activities coincide with our weekly scripture readings from the Revised Common Lectionary.

#### Holy Week

Springtime Family Fun-Bags and Palms were given out under our bright canopy outside. <u>82</u> were picked up by parents, teachers and those within the community. <u>27</u> were delivered and <u>32</u> bags were dispersed between local apartment communities. \*This figure is included above in the April KNI Fun-Bag count.

#### Children's Sabbath Sunday & Bible Presentation

<u>Five</u> children participated by leading prayer and reading scripture during the service. <u>One</u> child and his family also participated by leading us in song throughout the service. A children's Bible and devotional Bible storybook were presented. After worship, children and their families gathered in the Fireside Room.

#### **Blessings of the Backpacks**

In leu of this we did a special video montage presentation for Sunday Worship. The video was called "Back to School Blessings". This consisted of educators, students from pre-k through higher learning i.e.; college and technical schools. We had <u>44</u> photos of individuals to show which also included special background.

#### Valley's Third Annual Fall-Festival Event

This was changed to a Fall-Festival "drive-through" event held on a beautiful Saturday afternoon for three hours. Vehicles crept through the back alley greeted with decorated scarecrows, carved pumpkins and all. Guests were greeted by <u>nine</u> youth and children in costume! Guests continued through to view <u>seven</u> decorated canopies greeted by many of our Valley members in costume. We had a total of <u>22</u> adult volunteers. Our mission table collected any canned food items for St. Matthews food pantry. <u>50</u> bags were given out. The other <u>50</u> bags that remained were given to local apartments with children as well as a few to a local fire station. All in all, it was a very successful event.

#### **Christmas Eve Service**

At years end, in lieu of our Christmas Eve Nativity Tableau, a four-minute video montage was shown. This included an assortment of fun family photos and those taken throughout Valley's past years' Christmas programs. We included this during our online Christmas Eve service and it provided all sorts of memories for everyone. This was exceptionally well received.

#### Valley Community Children & Youth Choir Groups:

We offer a leveled choir program designed to meet the needs of children pre-k through 12<sup>th</sup> grade. We care deeply about the children and strive to provide a loving environment where each child feels like an important part of the group. We believe in the power of singing to shape the child into someone with confidence, poise and leadership skills.

#### **Choir Groups**

Eight Melodia Choir students have participated in the Zoom rehearsals. Many families did not want their young children to do any more Zooming than necessary so opted to wait for in-person choir to resume. 14 Armonia Choir kids have participated in the Armonia Zoom rehearsals. Again, some families opted to wait for in-person choir rehearsals to resume. We are moving ahead to make group recordings in February. 15 Cherub Choir students are sent a weekly choir video to their families. 11 New Spirit Ringers have participated in this new group! \$469 in funds was raised for the choir groups scholarship fund. This was held in Armitage following the Youth's choir concert on February 1, 2020.

#### **Choir Group Info:**

**Cherub Choir** (Pre-K through 1<sup>st</sup> grade)

Weekly YouTube lessons started in October. This enables parents with younger children to watch a prerecorded session at their own time where their children can participate in song and story time through weekly singing lessons. Lizz Brown leads as her husband Paul volunteers his time to assist with the proper lighting, video editing and sound. Children learn proper vocal technique and age-appropriate music theory. Emphasis is on joyfully making music.

**Melodia Choir** (2<sup>nd</sup> grade through 5<sup>th</sup> grade)

As of October 7, each Wednesday Amy Rheingans leads her Melodia choir group in a one hour Zoom lesson to develop their vocal technique and expand their music literacy skills through enticing games and activities. **Armonia Choir** (6<sup>th</sup> through 12<sup>th</sup> grade)

As of September 20, after worship hour, Armonia has a one hour Zoom practice also led by Amy Rheingans to cultivate their vocal technique intonation, and music literacy skills. A variety of musical styles are experienced, including traditional, classical, folk, and contemporary pop songs. Confidence, leadership, and musicianship are nurtured through the choir singing experience.

New Spirit Ringers (a mix of youth and occasionally parents too)

This new group began COVID-safe in-person rehearsals starting on November 1, 2020 for a one hour session per week on Sundays. New Spirit Ringers performed live in worship on Christmas Eve and will do so again in March and May of 2021.

### Valley Christian Preschool

2020 Annual Report for January-July 2020 Submitted by Anne Scearce, Former Preschool Director Kylie Cole, Current Preschool Director

#### January

- Open Registration began for 2020-2021
- Mandarin language lessons began for 4s classes
- 2019-2020 Vaccination records submitted to Washington County Health
- Celebrated Chinese New Year and VCP Spirit Week

2020 was an unprecedented and unconventional year for everyone. Here is a recap of how the preschool navigated the first half of the year. Valley Christian Preschool had 77 students enrolled for the 2019-2020 school year, enrolled at 88% of capacity. In January 2020, Open Registration began for the 2020-2021 school year. School tours for new families were scheduled almost daily in January. Registration for the upcoming school year was going well with the 4 year-old classes, which are the largest, already close to full for the upcoming school year. VCP began Mandarin language classes in both of the 4s classrooms every Friday morning starting in January. This marked the second year that Mandarin had been taught at VCP by Qian Xiang, a VCP parent, as part of our regular 4s spring curriculum. The students enjoy these classes and learn the language quickly. Additionally, in January, VCP submitted vaccination records to the state on behalf of all currently enrolled students. The last week of January the whole school celebrated Chinese New Year and VCP Spirit Week with pajama day, crazy hat/hair day and super hero day.

#### February

- Successfully launched new afternoon Pre-K classes (2 days a week)
- Open registration continued, school tours for new families

In February, VCP began our new afternoon Pre-K classes two days a week for the 4 year-old students. Enrollment for this new Pre-K class began in the fall of 2019 and classes started in February. Students enrolled in this program stayed an additional 2 hours one afternoon a week. The idea for this program came from Susie Erdahl, the lead 4s teacher. She planned the curriculum and taught this class which focused on reading, writing, math and science. The smaller class sizes provided more one-on-one teacher support. This extended day program was a huge success! It provided additional challenge to students that were ready to learn more, provided extra support to students that were struggling to prepare for kindergarten, while generating new income for the preschool of approximately \$1,400 a month. We planned to offer this program for 2020-2021 starting earlier in the year, in November 2020.

#### March

- Munch for Men, March 4-6
- School closure due to Corona Virus begins March 15
- VCP Family Blog launched provides links to teacher recorded videos

In early March there were rumblings that the Corona virus could soon impact the United States. The preschool held the annual **Munch for Men** brunch in Armitage Hall and the gym three mornings in a row, March 4-6. We revised the format of our brunch so that VCP staff served food and beverage to each dad and child to minimize spread of germs. On March 15, school closed per Governor Brown's direction. We all planned on returning to school by April 1.

In mid-March, developed a VCP Family blog website which provided preschool families with on-line links to videos of our teachers reading stories, doing art projects and leading students through other fun dances and activities which were accessible anytime. We added new videos to the blog several times week. Additionally, the blog included links to other online activities, curriculum and websites that were preschool appropriate and posted photos of what our students and teachers were doing at home.

#### April – May

- VCP Teachers lead live Zoom Preschool classes twice a week
- Researched salary options for VCP staff during COVID closure
- Reconciled pre-paid tuition for May 2020 due to closure
- Class activity bags distributed for all classes
- VCP staff assisted Children's Ministries with Easter and Spring goody bags
- 11 babies were born to VCP families during quarantine!

Each of the lead VCP teachers provided weekly live Zoom classes to both of their classes throughout the months of April and May. Zoom was an entirely new format for teaching preschool, and the VCP teachers did an amazing job of mastering the Zoom technology and reading, singing and dancing through 45 minute live classes online. Each student had a chance to interact. There were many technical challenges, but also some funny, silly live moments with our students!

I worked closely with Valley's Finance team to research best options to maintain staff salaries during school closure. We considered unemployment versus the Federal Payment Protection program and determined that applying for the Federal Payment Protection program was the best option. Receiving this financial aid allowed Valley to pay preschool staff salaries in full (10 employees) through the month of August 2020.

As part registration every year, VCP families pre-pay tuition for May, the last full month of school. Because VCP was not open in May 2020, we needed to reconcile this pre-paid tuition with each family. More than half of the VCP families decided to donate their pre-paid tuition to Valley, with donations totaling over \$12,000. Most remaining families decided to apply their prepaid tuition as a credit towards their 2020-2021 tuition. A small percentage of families requested a cash refund.

#### June – July 2020

- June 13 Drive-thru graduation event for VCP's 4-year old class
- Memory books for each student
- Applied for Preschool COVID Grant through State of Oregon
- Applied to open as an Emergency Childcare Facility in September
- Planned restructure to operate within COVID state guidelines
- Hired new preschool Director, Kylie Cole


On June 13, VCP held the first drive-thru graduation to celebrate the 33 Dragonfly students moving on to Kindergarten with the entire VCP staff in attendance. Each student received a personal memory book made by their teachers, a graduation certificate, and took a photo from their vehicles with their teachers. It was a very special day and gave us a chance to say farewell to our graduating 4 year-olds.

As is VCP tradition, all 2s students received a photo memory placemat and all 3s students received a personal memory book. All students also received activity bags from their teachers with crafts and curriculum to do at home. VCP staff also assisted Donna Carlson and the Children's Ministries team with construction of Easter and Spring goody bags.

Over the summer months, several revisions were issued to the state guidelines for early childcare operations by the state of Oregon. New regulations included smaller class sizes, social distancing between staff/classes, no contact at drop-off/pick-up and required teachers to wear masks while teaching. Together with the teaching staff, we developed many scenarios to be able to open while meeting these guidelines. In early August, 'final' guidelines were released that were extremely involved and among other things, restricted parents from entering the building. Additionally, all K-12 public schools decided to close and offer on-line learning. Several of VCP's teaching staff had school age children of their own and others had health concerns. Many factors of the COVID-19 pandemic and quarantine made it difficult for VCP to reopen in September for the 2020-2021 school year.





















### Valley Christian Preschool

2020 Annual Report for August-December 2020 Submitted by Kylie Cole, Current Preschool Director

In August 2020, Valley Christian Preschool entered under the new leadership of Kylie Cole as Preschool Director. After much discussion and in partnership with the teachers, it was recommended to session that we do not open the preschool in September 2020 due to the increasing risk of the coronavirus. The teaching staff were furloughed as of September 1, 2020.

The next four months were spent preparing VCP for a hopeful reopening in April 2021.

- Created a beautiful new website and updated social media accounts.
- Reorganization of the library and office space with high-quality donated furniture.
- Reorganization of the resource room and storage closets.
- Creation of a warm and welcoming foyer featuring a seasonal tree and joyful décor.
- Implementation of a playground reservation program where families could sign up to reserve the playground for a few hours and visit our new lending library where students could borrow books while the public libraries remained closed.
- Sent bi-monthly newsletters, content, and videos to families.
- Creation of new lesson-planning and reporting procedures.
- Updated the staff handbook to reflect current guideline and restrictions.
- Established an extensive health and safety plan as required by OHA and the ELD along with our "Covid Handbook" which carefully and thoughtfully explained the new guidelines, restrictions, and possible scenarios that could arise during our reopening.
- Updated our registration and enrollment processes and paperwork to be streamlined, contactless and 100% online.
- Once it became clear we could not open safely in January, we created an additional reopening plan for spring of 2021 with a new spring/summer program in hopes to increase our revenue, rebuild our community, and encourage enrollment for the following school year.

As of December 2020, Kylie primarily worked remotely, focusing on rebuilding the VCPC website, communicating and touring with prospective families, finalizing reopening pans and budgets, and coordinating the credits, refunds, and donations from 2020-2021 students.

### Personnel

The Personnel Committee at Valley Community Presbyterian Church serves and cares for our pastor, those on staff and the Valley Preschool employees. Several members have recently retired from the committee bringing our number to the lowest in recent memory. With three active members, and Pastor Jeff Binder, the responsibilities each carries increased and we look forward to welcoming new members. Not only has the committee itself seen a reduction, but in the first quarter of the year Valley had 28 employees receiving compensation in some form and by the fourth quarter that number had dropped to 15 employees, predominantly due to the pandemic. We all look forward to a fresh start in the next year with renewed hope and enthusiasm. The committee meets monthly on the first Monday via Zoom, with a full agenda that includes regular topics as well as current personnel issues needing immediate attention.

Supporting our valued employees during a pandemic gave us an opportunity to examine how we make connections and allow for flexibility during a difficult historical event. One committee member has a passion for personalizing employee care and has initiated a system of recognizing each person with electronic birthday greetings. Each employee also has a personnel liaison who connects with them every month by phone or email. Prior to the COVID restrictions, the committee also celebrated staff with regularly scheduled appreciation events such as an employee luncheon. Finally, the committee takes seriously our responsibility to support our pastor personally, spiritually and professionally.

In the last year, three major personnel changes occurred within our church home. First, we welcomed Kylie Cole as the Valley Preschool Director. She joins us with some impressive credentials and qualifications and we look forward to supporting her as she builds the preschool and adds additional educational opportunities for the community. Second, Pastor Chuck Falconer retired as a pastoral associate ending a career that spanned decades. We consider ourselves fortunate that he remains here as a prominent member of our church community. Last, David Jimerson, who served our church as the Director Music Ministry, without accepting a salary, will retire mid-year. When that times comes, we will miss his talent and generosity. Like Chuck, he will remain a well-respected member of Valley. David's impending retirement prompted the formation of a task force to examine the future of the music program in a church that values its place in our sanctuary. The Personnel committee feels confident the work of the task force will bring a successor who will lead us forward in our appreciation for music as a form of worship.

The Personnel Committee is accountable to the Session, with authority and charge to carry out the following:

- Oversee and write personnel policies and practices and make recommendations to Session.
- In collaboration with the Finance Committee, recommend salaries and benefits.
- Conduct annual performance reviews.
- Develop and maintain position descriptions.
- Assist in interviewing and hiring staff.
- Encourage professional effectiveness and growth.
- Support the staff.

Goals for 2021:

- Collaborate with the Finance Committee to build a long-range plan for employee compensation.
- Provide increased support for the pastor as part of our regular work.
- Hire a Director of Music Ministry
- Update the Valley Personnel Handbook and employment policies.
- Conduct annual performance reviews for all employees.
- Collaborate with Jeff on a pastor evaluation.
- Reinstate regular employee events and celebrations.

Persons of spiritual character, honest repute, exemplary lives, brotherly and sisterly love, sincere compassion, and sound judgment should be chosen for this ministry. - Dates: The Deacons met on the third Tuesday of the month
- **Time:** The meetings begin at 7:00 p.m.
- **Place:** The Fireside Room at Valley (or Zoom meeting)

#### **Compassion and Outreach**

- Home Communion: Deacons served communion to members and friends of Valley that were unable to attend church services.
- Rides to Church: Deacons arranged for rides to church for those without personal transportation.
- **Congregant Care:** Deacons stayed in contact with members and friends of Valley (with visits, cards, phone calls, emails) that have special needs or were unable to attend worship services.
- Get Well and Sympathy Cards: Deacons sent get well, sympathy and thinking of you cards to members and friends of Valley that were facing health problems or lost a loved one.
- **Grief Ministry:** Deacons contacted and sent a series of booklets to Valley members and friends to help them understand and cope with the grieving process following the loss of a loved one.
- **Memorial Service Receptions:** Deacons provided refreshments and hosted receptions following memorial services.
- **Maundy Thursday Communion Supper:** The Deacons were responsible for planning the supper (and service) with the pastor, and hosted the dinner.
- **Coffee Fellowship After Sunday Worship:** Deacons hosted Coffee Fellowship after Sunday morning worship service in January and October.

#### Congregational Life and Service Ministries

- Communion Preparation: Deacons provided and prepared the communion elements.
- **Bulletin Board:** Deacons have a bulletin board to keep Valley members aware of current Deacon activities.
- **Blood Drives:** Deacons worked with the Red Cross to obtain donors and volunteers to assist with Valley sponsored blood drives.
- **Prayers of the People:** Deacons presented prayers of the people on the third Sunday of the month.
- New Member and Baptism Welcome Letters: The Deacons sent letters to new members and the newly baptized welcoming them to the Valley family.
- **Church Officer Nominating Committee (CONC):** Deacon served on CONC to help with the recruiting of Church Elders and Deacons.

#### Summary of the Year

Due to the COVID-19 Virus, several of our ministries have been put on hold. We continued to send get well and sympathy cards, and grief ministry booklets to Valley members and friends that have experienced the loss of a loved one during the year. We also stayed in touch with members and friends of Valley that have special needs.

We worked with the Red Cross to obtain donors and assist with four (4) Valley sponsored blood drives this year.

Deacons continued to present Prayers of the People on the third Sunday of the month and a baptismal banner was presented to Joyce Wood's family.
