2018 Annual Meeting Minutes Gloria Dei Lutheran Church Annual Meeting Agenda January 28, 2018, 12:45 PM

- 1. President Ashley Weisz called the meeting to order at 12:37
- 2. Opening Devotions were given by Pastor David
- 3. Approval of the 2017 Annual meeting minutes
- Marg McKennett moved to accept minutes, Kathy Molland 2nd, motion carried.

4. Treasurer's Report – The additional \$1,000.00 per month continues not to be paid on the mortgage; the Mortgage Reduction Fund needs additional donations as it continues to run in the red. Council transferred funds from the Building Fund to the Mortgage Reduction Fund at the January 2018 council meeting in order to bring the Mortgage Reduction fund to zero.

• Rick Clemes moved to accept treasurer's report, Judy Hogue 2nd, motion carried.

5. Pastors' Report – Pastor David expressed gratitude for how GDLC expresses being the body of Christ. The youth programs, building houses in the Caribbean, quilts for Lutheran World Relief, and more are all ways our church has been the body of Christ. He is also grateful for the people he shares ministry with: Bill Christensen for his deep faith and integrity, Steve Peters who has been welcomed warmly and is starting with Wartburg Seminary, Ann Nelson and Amber Ogaard for keeping the whole church running, and Wayne and JoAnne Colebank for tending to the facility. He said we have both challenges and opportunities in our future, but God is always ahead of us.

6. President's Report – Appreciation for the council that has worked hard this past year while being short-staffed. Praised the energy and excitement of the youth in our church, and challenged the congregation to take part in fostering and harnessing that energy. Also expressed gratitude for the congregation's willingness to embrace the creative ministerial support options that were presented to them at the congregational meeting in October. That openness to other opportunities is refreshing and heartening.

7. Committee Reports – The committee reports for Evangelism, Property, Worship, Stewardship, Parish Ed and Youth were printed in the Annual report. All committees are welcoming new members.

- 8. Unfinished Business
 - a. The call committee has been active all year, though not meeting due to the discussion process regarding possible ministry partnerships with Steve Peters and St. Peter's Episcopal Church. The line item for an associate pastor that was included in the 2017 budget was zeroed in the 2018 budget that council sent to the congregation for approval. President Ashley Weisz explained that because the call committee is not officially disbanded, the congregation will need to determine if they would like to continue the call process, and if so they will need to amend the budget in the annual committee report to include a line item for an associate pastor.
- Dick McKennett moved to continue the call process, and Linda Clemes 2nd. President Ashley Weisz asked for discussion and questions.

Drew Robinson, member of the call committee, spoke about a meeting had with Sherie Heinie from the synod explaining the shortage of candidates and the low chance of candidates being assigned to our area. He said he is thankful that we have Steve Peters here and the opportunity to work with him as he goes through seminary. He also stated that he feels having both Pastor David and Steve at GDLC, but also continuing with the call process, may stretch the synod's resources even further than they already are as they work to fill positions at other churches that may not have any rostered leaders. He feels our focus as a congregation should be on getting our members to step forward.

Deb Kemp agreed with Drew and stated that we should look at revising the job

descriptions of our current staff. As an example, she mentioned all the work Ann Nelson does with our youth and the possibility of making that work part of her job description. She also stated that our church may need to be creative in how we approach the need for additional ministerial help for Pastor David.

Rick Clemes spoke about the Stephens Ministry program that is getting up and running, and said that people are gifted in different ways. Stephens Ministry may not be for everyone, but there are plenty of opportunities for people to use their gifts in ways to help the church. In short, the members will have to be the ministry.

Dick McKennett stated that it is a tough situation to be in, deciding whether or not to keep the call process open in hope of finding someone when we are aware of the shortages of rostered leaders. He explained that the \$65,000 that was budgeted in 2017 would not be enough should the congregation vote to continue the call process. He stated that the synod felt we would need to budget at least \$75,000, and that the line item needs to be in the budget to show our commitment to the call process.

Dick McKennett amended his motion: Continue the call committee for the purpose of being
open to various positions (for example: associate pastor, youth & family leader, etc.) to assist the
congregation and Pastor David, and to empower the call committee to redefine the position that
may be available. Linda Clemes 2nd the amended motion, motion carried.

9. New Business

a. Approval of 2018 budget-

Dick McKennett presented the proposed 2018 budget in place of outgoing treasurer Lois Reierson who was unable to attend the meeting. He highlighted the changes to the budget:

- i. Income for 2018 is budgeted at \$325,800.00
- ii. A benevolence for Community Connections has been added at the request of the Evangelism Committee to show GDLC's commitment to the shared ministry work they are doing in Williston. The amount budgeted is \$1,420.00
- iii. The Faith pastoral supply amount has been separated out, but the amount is unchanged. It was a bookkeeping decision so the amount currently being paid to Bill Christensen is easily located.
- iv. The budgeted amount for pulpit supply has been reduced significantly because Steve Peters's presence at GDLC should reduce the amount of external pulpit supply we need.
- v. Cost of living raises were given to the church staff.
- vi. Line items have been added/updated to reflect Steve joining our church staff.
- vii. The Property Committee budget has been reduced due to Wayne Colebank's assistance with snow removal.
- viii. The 2018 budget is proposed with an overall deficit of \$64,663.71. This takes into consideration that the \$65,000 that was budgeted in 2017 for an associate pastor was zeroed. Dick reminded the members that the proposed budget would need to be amended in order to add a line item for the continued call committee vote that was just passed.
- ix. Drew Robinson asked for clarification on the amount listed in the budget for Ann Nelson. All staff was given a cost of living raise, yet her total amount in 2018 is reduced from 2017.
- a. Floyd Peterson, who is on Personnel Committee, explained that the reduction in total dollars is due to Ann requesting fewer hours. Her pay rate has gone up, but her hours are down which is why the total is lower despite the raise.
- b. Drew then expressed appreciation that the church gives its staff a raise in recognition of the work they do.
- Dick moved to amend the 2018 budget by adding a line item for \$75,000 for an associate pastor, or whatever position is deemed a best fit by the call committee in line with the earlier vote. Norm Hanson 2nd, motion carried.
- Dick moved to approve the 2018 budget with the added \$75,000 and the budget totals adjusted accordingly. Judy Hogue 2nd, motion carried.

10. Nominating Committee Report

a. Members Kent Reierson, Wayne Colebank, Jerry Fleck, Dick McKennett, and Roger Altenburg worked diligently to fill needed council positions prior to the annual meeting. Following is a list of the new positions being filled (current council members who are still serving a term are listed in parentheses).

President – Wendy McGinley Past President – (Ashley Weisz) Vice President – Rick Clemes Treasurer – Jeramy Hansen Secretary – Kathy Molland Parish Ed – Sherry Weyrauch (Heidi Jeanotte) Evangelism – Cheryl Nelson (Judy Hogue) Property – (Mark Telehey) Stewardship – Terry Olson Worship – David Rod Youth – (Bill Reeb)

- i. Terry Olson had originally agreed to serve as Property Committee's second representative, but during the annual meeting volunteered to change his committee membership (and council rep duties) to Stewardship to ensure that each committee has at least one representative on council.
- ii. Kathy Molland will serve as secretary for one year, and Jeramy Hansen will serve as treasurer for two years in order to ensure that the secretary and treasurer terms alternate as required by the church constitution.
- iii. Mark Telehey has agreed to stay on council for an additional year as the Property Committee representative.
- iv. Committees still in need of additional representatives: Worship Committee, Property Committee, Stewardship Committee, and Youth Committee (needs one youth rep).

Bethel Delegates – Sandy Moldenhauer and Donna Peterson

UMM Delegates – JoAnne Colebank and Rachael Studsrud

Personnel Committee – Floyd Peterson and Wayne Retzer will stay on. Lola Christensen has stepped away from the committee as it is difficult for her to attend the meetings. Lois Reierson has agreed to join the Personnel Committee.

Linda Clemes moved to cast a unanimous ballot for the abovenamed positions. Lisa Hanson 2nd, motion carried.

b. Nominating Committee – This committee is a one-year commitment, and requires three members from the congregation at large, and two additional members from council. President Ashley Weisz explained that the council will select their representatives at the next council meeting, but that the at-large members from the congregation needed to be selected during the annual meeting.

Dick McKennett expressed that the lack of volunteers for many of these committee and council positions is an example of the problem that GDLC, and many other churches, face. The ministry of the church and the business of the church both require the commitment and work of its members to be done.

President Ashley Weisz reminded the members present that while Nominating Committee isn't an easy committee to be part of, it is a very important committee. Their work directly and positively impacts the ability of the church council to do their work.

Linda Clemes, Jan Stoner, and Karen Olson all volunteered to serve on the Nominating Committee for 2018. Their willingness to serve is greatly appreciated!

- Alberta Parisien moved to approve the at-large members of the Nominating Committee, David Rod 2nd. Motion carried.
- 11. Meeting adjourned at 1:39 with the Lord's Prayer.

Treasurer's Report

This has been my first experience on a church council and I can tell you it has been a fulfilling experience. I ask that members of the congregation consider stepping up and joining council or joining a committee.

Staff changes at the church have made 2018, and planning for 2019, quite challenging from a financial standpoint. There are many unknowns at the time I am writing this, but one thing is known: **giving will need to increase**. As you can see in the charts on the next two pages, our giving is down and our expenses are up. As our congregation and youth programs grow, so do our expenses. Increases to expenses have been with the church staff and will increase quite a bit more if an Associate Pastor is hired.

The church's budget has not included oil income received or the mortgage payments made throughout the year. Oil income and mortgage reduction offering has been going towards paying the mortgage payments with any additional money needed to pay the mortgage payments paid out of the building fund. At the end of 2017 it was \$10,697.37 that was needed from the building fund to pay mortgage payments. At the end of 2018, we have a positive balance of \$4,456.93 in the mortgage reduction fund.

The mortgage is scheduled to be paid off in January 2020. I can say with some certainty that this will be the last annual meeting where the mortgage will be included in discussions about the future because I envision us paying it off before January 2020.

Looking at the budget for 2019, there is a deficit of \$100,481.62. There are areas in the budget that are not certain due to office changes, Steve Peters' leave of absence, and the search for an Associate Pastor. As you can see in the last chart, there have been budgets with sizable deficits in recent past mostly because of an Associate Pastor being included in the budget, but the actual deficit has not been as high mainly because an Associate Pastor hasn't been found. For example, in 2018 we had a budgeted deficit of \$139,663.71 and an actual deficit of \$18,515.00.

Because the mortgage will likely not be part of the budget after 2019, I want to provide a picture for what that will mean for the church finances after it is paid off. The last page of the 2019 budget shows the 2019 projected mortgage reduction offering and projected oil income. It is very difficult to predict, but if the mortgage reduction offering we receive continues to be made to the church as regular offering and if oil income stays at its current level, we are looking at approximately an additional \$64,000 in cash flow for the church after the mortgage is paid off.

The future is bright for Gloria Dei and I am excited to see what the future holds. Thank you for your financial support in 2018 and your continued support in 2019.

Pastor's Report

"I know the plans I have for you, plans for a future and a hope..." Jerewiah 29:11

To the beloved of God gathered at Gloria Dei,

These words contain a timeless, vibrant truth- **God is in charge.** Think about it for a moment, God has a dream, a plan, a future and hope not only for each one individually, but for His people- you and me and the congregation called Gloria Dei.

It is tempting; indeed, it is our human nature to be caught up in the busyness of the ordinary. This is true of our individual and family life, it is true at work, and it is true in our life together as a congregation. Yet, every once in a while, it is good to take a breath, to pause and look back over the shoulder at where we've been. Likewise, we need to look down the road to imagine the future, make sure we're on the right path. In the wisdom of this verse, it is also a divine invitation to tune our lives and ministry to the plans, future and hope which God has for us.

One of the ways we can do this as a congregation is to measure our ministry together with our God -given mission. For Gloria Dei that mission is **"Gathering to Grow to the Glory of God"** You know me, I add another ""G" as the gospel calls us also to "Go"- to go into our families and in our relationships, to "go "into our workplaces and into our leisure; to "go" wherever you are and what ever you do, "go" and let your light shine.

Here are some thoughts about where we have been and where God is calling us to as we enter a new year. I would be deeply interested in your comments, your reflections...

Worship-this is the heart of the Christian faith. As Jesus said, Where two or more are gathered, there I am.." We don't gather because its habit, or because of what we get from worship- we gather because God calls us, promises to be with us, and comes to us in Word and Sacrament. There is not place God desires to be more than with the family... how about you, how about me?

Question for reflection...Our lives are busy, and for many among us the weekends take us away. How do we gather in the midst of life to be with God, to know his presence and seek his future? Might God be nudging us to a mid-week worship geared for families and the abundance of children gathered around the tables? What does it mean for you to "Gather, grow and go" as you experience worship?

Education/ Faith Formation- Gathered around the Word, this is our most visible expression of "growing." One only has to come to church on Wednesday evening to see that walls are being stretched by a multitude of God's kids! Or come and join the adventure of our Confirmation youth as we discover God, faith and the claims of Jesus in our lives. Or come with our Sunday adult group, the Saturday men's breakfast and Bible Study...

Question for reflection...We are blessed, but we have opportunities. From my position the biggest opportunity/challenge is not the abundance of children, it is the Biblical ignorance of adults. We don't know the Bible, indeed for some it is intimidating and out of our comfort zone. What may God be stirring in us as we consider ways to "grow" not only for kids and youth, but for the children of the Holy One of all ages?

Serving- this is where the call to "go" takes on flesh and bone in your life and mine. As a community of faith we do this quite well. Consider

Dear Friends in Christ at Gloria Dei and Faith Lutheran Churches, In the words of Martin Luther when he met Katie, "Hi"!

I am David Maxfield and it is my joy to share with you in the ministry of our Lord Jesus as your pastor. Please allow me to tell you a bit about myself, my family, and my faith.
