He described five types of Pastors that could be called by a church. Ranked number one was a type called **catalytic Pastor**. They were described as being entrepreneurial and charismatic. The type de-

scribed as **Chaplain Pastor** was number four in the hierarchy. Their focus is on helping hurting souls find healing. Chaplain Pastors were denigrated in this hierarchy. Because of their inward focus on the members of the church, the Chaplain Pastor is seen as fatally injuring the church.

Galli appears to look at the Pastors in the New

Testament. He does not appear to believe that Jesus, Peter, Paul or Thomas were in the Entrepreneurial mold.

ICPC Pioneer Retires from Service

Rockford Police Chaplain William Wentink Retires

Rockford, IL — Reverend William R. Wentink is the founder and volunteer Head Chaplain for the Rockford, IL, city Police and Fire Departments. He came to Rockford just out of seminary and was assigned to St. James Catholic Church. Shortly after arriving he visited the local police department and asked then Chief Delbert E. Peterson if he could ride with some of our police officers. The Chief agreed and the first night Father Wentink rode with the officers, they were called to a fully involved house fire. In that fire 3 children were killed. The police officers and fire fighters all turned to Father Wentink and said, “you’re a priest – you go tell the parents their children are dead”.


Since that day in June of 1970 Father Wentink has been serving the Rockford Police and Fire Departments as a volunteer Chaplain. He has been available 24 hrs per day, 7 days per week, 365 days per year. In 1971 the Police Benevolent & Protective Association.- Unit 6 asked Chief Peterson if Father Wentink could

officially be named the Rockford Police Department Chaplain. This was done in 1972 and Chief Peterson presented him with a Chaplain badge. Under Father Wentink’s direction the program has been expanded several times. In May of 1974, up to 30 more volunteer Chaplains were added to the roster – one assigned to each day of the month – to help with the volume of calls coming in. In 1978 a paid position of Personal Services Officer was added to the program to help with coordination and more in-depth assistance to police and fire personnel – active and retired. In 1985 a paid secretarial position (which was later expanded to Outreach Worker) was added to help with the increased paperwork and activities.

Under Father Wentink’s direction our program has gone from giving out approximately \$200 per year in donated funds for those in need to giving out up to \$200,000 of donated funds in any given year.

He has spoken to countless groups throughout our city and regional area promoting what our program does in the community. Our Chaplains and staff partner with all walks of clergy and religious groups, area helping agencies, benevolent community organizations, and generous businesses to meet the needs of those who are hurting, suffering, and in need of basics such as food, transportation, lodging, clothing, and medicine just to survive.

During his 41+ years of service, Father Wentink has never lost his main focus of being there for police officers, fire fighters, 911 center operators and their respective families. Since the beginning our program has received overwhelming support from the rank and file of both the police and fire departments, each department’s respective Chiefs, our local Aldermen, and each serving Mayor. That is mainly due to the trust Father Wentink has established

and the rapport and integrity he has maintained over the years. He has spent countless hours helping first responders deal with the horrific tragedies they have seen and dealt with in their line of duty. He did Critical In-

ICPC Conducts Training Classes For Guatemala Police Chaplains

GUATEMALA CITY, Guatemala— Our team had all arrived in Guatemala City within a half hour of each other and now, six days later we were trickling out, tired but elated, to return to our homes. Heavy rainfall during the week and roads in the country being closed by mudslides were the only damper on the very exciting training conducted.

We were a diverse team with diverse departures. First it was Jim Davis from New Jersey, and the next day early morning it was Tito Rivera from Idaho, and later that day I left for my home in Washington State, and then finally the following day, it was Gary and Maxine Welsh from Jamaica.

We had gathered from

across the western hemisphere to meet in this Central American country in fulfillment of a vision to have an active serving chaplaincy for the Policia Nacional Civil. Translated, that is the National Civil Police that had been set up after years of civil war.

An American, ex-police officer, had taken up residence in Guatemala, served at their police training Academy and saw the need for police chaplains to support this nations beleaguered police officers. I was asked by the Destin office of the ICPC to begin to communicate with him to see what we could do to assist.

To describe the fits and starts of the ICPC efforts would take many pages, but just let it be said that the training held for the first 80

You can help also be notifying me when any of your people are in need of prayer. There are many I miss because I am not informed of the need. You can be a tremendous help by contacting me so that the names can be placed on our prayer list.

An additional way to help is to keep me informed of the progress in recovery of the wounded and sick. It is good to put them on the prayer chain, but our fellow chaplains also need to be kept up-to-date on how they are doing. Will you make the effort to allow me to notify our chaplains of recovery or of any other situation? I and your fellow chaplains will greatly appreciate your assistance in this regard.

Canadian Police Chaplains hold ATS

REGINA, SK—The Canadian Police Chaplains held their annual training seminar in late October.

ICPC Basic Courses were taught with one advanced class and enrichment classes on Tuesday through Thursday.

Phil Anaquod of the First Nation shared the philosophy and beliefs of the Indians in Canada. Imam Abdullah Hatia explained his Muslim faith while Rabbi David Callan talked about Jewish culture.

The Banquet was held on Thursday evening with much pomp and circumstance. RCMP Corporal Natasha Szpakowski talked about how chaplains helped her when her husband, a Mountie Constable was killed on a call.

The Memorial Service was held in the RCMP chapel on the Training Academy for all their recruits. Since 1895, it has been the spiritual home for the Royal Canadian Mounted Police.

A tour of the training center was given before the chaplains ate lunch in the Dining hall with the Recruits.

The ATS ended with a parade and inspection of the recruits.

chaplains for the PNC was at least five years in its development.

Through the diligent efforts of Norma Hasbun, head of the Valor and Services Unit of the PNC, Mike Watkins, an American pastor of an indigenous church in Antigua and his associate pastor, Antonio Sandoval, permission was granted by the Director General of the PNC to move ahead. The availability of the PNC Training Academy was promised and we were ready to move ahead. Then, due to scheduling conflicts, the Academy was no longer available and only more expensive retreat centers seemed an option... but there was not enough money. We were in that dilemma during the ATS in Jamaica when our new Vice President of ICPC, Mark Clements, stepped forward and offered the final dollars needed to make the training happen!

Our team arrived on October 15th, spent a day in final preparation and then embarked on teaching the

sixty-five serving police officer/chaplains and some fifteen pastor/chaplains. What eager students as they hungrily absorbed the ten classes we offered and clamored for more. During the three day training we taught them a modified “Basic” course appropriate to their culture to include, Servant Leadership, Basics of Counseling, Anatomy of a Crisis, the Police Family, Suicide Assessment and Intervention, Dealing With Addictions, Stress Management and others.

At the end of the training they proudly re-

ceived their certificates of accomplishment, their badges declaring them chaplains in the PNC and then posed for a multitude of pictures.

We agreed that this is just the first of the Central American nations to be added to the now flowing stream of other nations that ICPC has included in our training efforts outside of North America. Our future efforts, possibly into Puerto Rico, El Salvador and Honduras will be guided by Regional Director Gary Welsh and our new contacts.

cident Stress Management before anyone had labeled it CISM. He has been there when they needed someone to marry them, christen or baptize their children, bury their loved ones, and he has helped them deal with the personal crises we all face in everyday life. He has handled a wide range of duties from making death notifications, to counseling personnel, to representing both our police and fire departments at local, state, and national ceremonies.

He has been there to welcome our new recruits, congratulate those being promoted, and wish well those who are retiring. He has presided over the ceremonies for our police officers who have been killed in the line of duty, supported their family members throughout the years, and established an annual Police Memorial Service to always remember our fallen. Additionally he has been called upon to help and support the families in our area whose loved ones have been injured or killed in the Iraq and Afghanistan wars.

Father Wentink has also been involved on state and national levels. Shortly after he began as a Chaplain in Rockford, he early discovered the International Conference of Police Chaplains. He has attended 36 Annual Training Seminars and countless Regional Training Seminars.

Under the direction and guidance of Father Wentink, the other two founders, and

those who have served since the establishment of this organization, the ICPC has grown to a current membership of over 2,300 Chaplains who currently represent 20 countries around the world. The training and support the ICPC offers their members is second to none.

Father Wentink has helped start, train and support many Chaplain programs throughout the United States, mainly in our northern Illinois/southern Wisconsin region. The Rockford Police and Fire Chaplains model has become a leading example for those seeking to establish a Chaplain program within their department. On a state level, Father Wentink has served as an Illinois State Police Chaplain and represented the Rockford Police Department at our annual state-wide Police Memorial Day activities. He has been available for our local Illinois State Police District #16 officers whenever they have called.

Nationally, he has represented the Rockford Police Department at the dedication of the National Police Memorial in Judiciary Square in Washington D.C. and was instrumental in making sure the family members of our fallen officers also had a chance to attend the ceremony. Through his pioneering membership of the International Conference of Police Chaplains, Father Wentink has set the standard high for Chaplains programs throughout the world. **He has led the way in the training,**

credentialing, equipping, and supporting of all ICPC Chaplains. Within the ICPC he has served on numerous committees. For many years he was the ICPC Regional Director encompassing the Illinois and Wisconsin region. He is a credentialed Police Chaplain, gaining the level of Master Chaplain. He served as the ICPC Credential Committee Chairperson from 1980 until 2002 and received a Special Recognition Award for his years of service and leadership of this committee. Additionally he was one of the earliest recipients of the ICPC Jack A. Price Award for Excellence in Chaplaincy, one of the highest honors the ICPC bestows.

Father Wentink is also a longtime member of the national Federation of Fire Chaplains and works through that organization to assist Fire Fighters and Fire Chaplains throughout the nation. He has also trained and served as an FBI Chaplain where he helped agents in the Field Office. He has spent tireless hours serving during some of the worst national disasters in our country's history – two that come to mind are the explosion of TWA 800 off of East Moriches, NY, in July of 1996 and in New York City at "Ground Zero" after the United States was viciously attacked by terrorists on 9/11/2001. His dedication to chaplaincy has been exemplary and serves as a model for committed emergency service chap-

lains.

Obviously these are only some of the highlights and accomplishments of Father William R. Wentink. Neither space nor time allow the telling or listing of the countless stories, achievements, and awards that have been given to Father Wentink over his 41+ years of volunteer service. He would note that the credit belongs to the Chaplain Division as a team, that due to the excellent volunteer Chaplains and the staff who have served with him. But no organization excels or accomplishes so much without an excellent leader. Father Wentink leads with integrity and compassion. He values, encourages, recognizes, and supports the people who work for and with him. He shares his knowledge

and expertise with any who want to learn

Even though Father Wentink's accomplishments are many and his commendations and awards are numerous, he prefers to humbly work behind the scenes in a selfless manner, never asking or seeking recognition, giving freely of his monetary resources, his talents and abilities, and especially of his time. He is God's servant with a true servant's heart. He has spent hours listening, caring, comforting, and getting people through some of the toughest times in their lives. He has taken on and perfected a task no one wants to have to do, that of delivering a death notification. It's the worst news that anyone could have to deliver or hear – that a loved one has died – and Father Wentink does it with the

infinite grace, great compassion, sensitivity, care, and expertise.

The width and depth and breadth of his influence and the difference he has made in the individual lives he has touched are immeasurable. In a tangible way, he only seeks to bring God's Saving Love, Saving Grace, and Saving Mercy to those in crisis. He firmly believes in and follows the edict in Matthew 26:40 "Whatever you have done unto the least of these my brothers, you have done unto Me".

He exemplifies God's instructions in Micah 6:8 "And what does the Lord require of you? To act justly and to love mercy and to walk humbly with your God". Father Wentink will one day hear God say: "Well done my good and faithful servant".

The ICPC Memorial Bible Program

One of the very significant ministries of the ICPC is the Memorial Bible Program. On April 17, 1984 the first Memorial Bible was sent from the ICPC to the Miller County, Arkansas, Sheriff's Department. The ICPC had traditionally sent a letter of condolence to those who had lost a law enforcement family member in the line of duty. The Bible is sent to the chief executive of the department to be presented to the slain officer's family or placed in the department library.
