## **Christ's Ambassadors Club Invitation to Participate**

*We are therefore Christ's ambassadors, as though God were making his appeal through us.*

Recently, a new ministry of the Southern Ohio/Kentucky District was born. This task team was formed to look at informing and acting upon racial justice. This Racial Justice Team is currently sponsoring a Lenten series via Zoom. Here is what Jon Keller from our Troy congregation shares about the evolution of his racial bias and his work with the Racial Justice Task Team of the Southern Ohio/Kentucky District.

*"Years ago, my daughter Kirstin chose to attend college at the University of Toledo. Although our family gave her a hard time about not attending a Church of the Brethren college, I was excited for the choice she made and the new experiences she was going to have in this urban setting. At the time, I didn't realize how her education and experiences in Toledo were going to challenge me to my core. Kirstin made friends with people of all ethnicities, and even met her now husband, Desmond, a black man, while at UT. When Kirstin and Desmond were friends, I enjoyed joking around with him during visits to campus. But, a few years later, when Desmond asked me if he could marry my daughter, something began to stir deep in my soul that exposed some of the prejudices I held.*

*"It was not an explicit racism, but an implicit bias, that was ingrained in me by a system in which I grew up. I was always told that racism was wrong, but my environment taught me something else. After a long conversation, I committed with my daughter and son-in-law to walk beside them in full support of their marriage, knowing they would face real challenges in choosing an interracial relationship.*

*"Little did I know how literal that statement would become on June 1st, 2020 when my daughter asked me to walk with her in a peaceful demonstration in Troy, Ohio after the murder of George Floyd. During this walk and in the days after, I realized the real danger that racism poses to all of our lives, but especially the lives of my son-in-law and two grandchildren.*

*"Desmond and Kirstin will tell you it took them a long time to find a faith community in which they felt welcome. I am blessed to be in a church that is willing to walk with my daughter, son-in-law, and our family, to learn about racism, and work to bring about racial justice within our own community. Therefore, I would like to thank the District Leadership Team in helping to develop and support the newly-formed District Racial Justice Team." --Pastor Jon Keller, Troy CoB*

- David Balmer, who pastors Flat Creek and Mud Lick congregations in a team with Dwayne Yost, is in a Lexington hospital. David had surgery for a blockage and hopes to return home today, but will need to return for another surgery to resolve another blockage in two weeks. Please be in prayer for David and his wife Bettina along with the congregations as David is being treated. David thanks us for the ongoing prayers.

- We continue to lift Bob Cain, retired CEO of the Brethren Retirement Community, as he deals with cancer and is in hospice care

- Staci Peterson, associate pastor at Cincinnati, shares the following concern - "in July 2019, I was diagnosed with idiopathic pulmonary fibrosis. This is a progressive disease that will continue to get worse. The damage can't be reversed but we can hope to slow its progression. I have been doing well so far with medication to help slow the progression of the disease, pulmonary rehab, and immune suppressants to control my lupus. While the lupus didn't cause the fibrosis, it can make it worse so I have to keep the lupus under control too. I did have to use oxygen for almost a year to help me breathe, but I've improved to the point I don't need it anymore. In the next couple of months, I will be starting the process of testing and evaluation at OSU to see if I'm eligible for a lung transplant. I appreciate prayers for health and guidance with moving forward"

- May we lift those affected by the power and water shortages in Texas as this situation continues.

- There are many reports of medical personnel being pushed beyond limits in caring for those in the hospital and in nursing homes. With news of the vaccine, hope is beginning yet there is still a long way to go before the end of this pandemic. May we lift these persons into the light of God's grace and love as they minister to those who are hurting.

- As a ministry affiliated with the District we have a longstanding and close relationship with the Brethren Retirement Community (BRC). Due to circumstances in the community and regulations, testing continues among residents and staff. Procedures are being conducted to keep our residents and staff safe. There have been a few positive cases and special care is being offered. Some vaccines have been administered.

May we all hold the entire BRC family (residents and their families, staff and their families, BRC Board members and their families) in the light of God's grace, mercy, wisdom, and healing in the coming days.

- As the situation with the coronavirus continues, may we remember those affected by this outbreak. There are many changing directives, regulations and recommendations affecting our country and way of life, may we remember all those adjusting to this changing world.

- May we remember those congregations in pastoral transition - the Constance congregation is exploring a yoked arrangement with Cincinnati with the Cincinnati pastors providing leadership for the next few months. Andrew Wright is serving as interim at Oakland. Donnels Creek is using pulpit supply at this time. Mark Lancaster is serving as interim at Good Shepherd but the congregation has decided to call Mark to the called position, an installation is being planned; Fred Bernhard is serving as interim pastor at Brookville during this time of transition; their profile has been posted. White Cottage has entered an agreement with a neighboring congregation to supply pastoral services during a time of transition and discernment. Tara Hornbacker is serving as interim at New Carlisle.

- There are many issues and situations continuing to face us as we minister in our respective locations, including those who are serving in interim situations and others who are in discernment regarding placement or are considering a move. There are others facing health issues, please keep these situations in prayer.
