"First, research clearly demonstrates that family structure matters for children, and the family structure that helps children the most is a family headed by two biological parents in a low-conflict marriage. Children in single-parent families, children born to unmarried mothers, and children in stepfamilies or cohabiting relationships face higher risks of poor outcomes than do children in intact families headed by two biological parents. Parental divorce is also linked to a

range of poorer academic and behavioral outcomes among children. There is thus value for children in promoting strong, stable marriages between biological parents."

"But the psychological revolution's focus on individual fulfillment and personal growth changed all that. Increasingly, marriage was seen as a vehicle for a self-oriented ethic of romance, intimacy, and fulfillment. In this new psychological approach to married life, one's primary obligation was not to one's family but to one's self; hence, marital success was defined not by successfully meeting obligations to one's spouse and children but by a strong sense of subjective happiness in marriage — usually to be found in and through an intense, emotional relationship with one's spouse. The 1970s marked the period when, for many Americans, a more institutional model of marriage gave way to the "soul-mate model" of marriage...

...Thirty years later, the myth of the good divorce has not stood up well in the face of sustained social scientific inquiry — especially when one considers the welfare of children exposed to their parents' divorces."

"Family trends of recent years have been largely generated by a distinctive set of cultural values that have come to be labeled 'secular individualism.' This value set, which already predominates in the northern European nations, consists of the gradual abandonment of religious attendance and beliefs, a strong leaning toward 'expressive' values that are preoccupied with personal autonomy and self-fulfillment, and a political emphasis on egalitarianism and the tolerance of diverse lifestyles. An established empirical generalization is that the greater the dominance of secular individualism in a culture, the more fragmented the families. As America continues to move in this cultural direction—as by all current empirical evidence it is—the family can be expected to continue to weaken."

It should be acknowledged that research on lesbian and gay parents and their children, though no longer new, is still limited in extent. Although studies of gay fathers and their children have been conducted (Patterson, 2004), less is known about children of gay fathers than about children of lesbian mothers. Although studies of adolescent and young adult offspring of lesbian and gay parents are available (e.g., Gershon et al., 1999; Tasker & Golombok, 1997; Wainright et al., 2004),

relatively few studies have focused on the offspring of lesbian or gay parents during adolescence or adulthood. Although more diverse samples have been included in recent studies (e.g., Golombok et al., 2003;Wainright et al., 2004), many sources of heterogeneity have yet to be systematically investigated. Although two longitudinal studies have been reported (Gartrell et al., 1996, 1999, 2000; Tasker & Golombok, 1997), longitudinal studies that follow lesbian and gay parent families over time are still needed. Thus, although a considerable amount of information is available, additional research would further our understanding of lesbian and gay parents and their children."

## Lesbian Mothers Think Their Children Are All Above Average

### Description

A critical response to a published study by the National Longitudinal Lesbian Family Study which claims that "children of lesbian mothers do better than children from a married-mom-and-dad family." The article cites reasons for the study being skewed and inaccurate.

### Quote

The "study" is neither objective nor comprehensive. There are three major problems with it:

- 1) The "research" consists of the mothers' opinions about their own children;
- 2) Only 77 lesbian couples participated in the "study," and they were not typical parents in other regards. An earlier NLLFS report described the sample population as Caucasian (93 percent), predominantly college-educated (67 percent), mostly middle- and upper-class (82 percent), professional or managers (85 percent), and earning a median household income of \$85,000; and
- 3) the study did not consist of a random sample -- all the participants were volunteers recruited via posted announcements in women's bookstores, at lesbian events, and in lesbian newspapers in three major metropolitan areas (Boston, Washington, D.C., and San Francisco).
